RESOLUTION NO 500

CACHUMA OPERATION and MAINTENANCE BOARD

EXPRESSING APPRECIATION AND THANKS TO Jan Abel

WHEREAS, Jan Abel representing the Montecito Water District has served in an outstanding manner from 1992 until April 2010 as a Director and President of the Cachuma Conservation Release Board (CCRB), and from February 2000 until April 2010 as a Director, past President, and past Vice-President of the Cachuma Operation and Maintenance Board (COMB); and

WHEREAS, Ms. Abel has served exceptionally as a representative for CCRB in negotiations with the Santa Ynez River Water Conservation District, Improvement District No. 1, the City of Lompoc, and the Santa Ynez River Water Conservation District to reach agreement on the operations of the Cachuma Project to both maximize the available water supply and ensure that the Cachuma Project does not adversely affect the water quality of the Lompoc Groundwater Basin, during which Ms. Abel's extraordinary effort was indispensable in bringing about an historic Settlement Agreement among all the water purveyors on the Santa Ynez River; and

WHEREAS, Ms. Abel has provided her experience and expertise to COMB during a very active and critical period in the history of the Board, including: COMB's participation in the Santa Barbara IRWMP resulting in a \$25 million grant, of which \$3.2 million will help fund an essential pipeline project; expansion of the Lauro Reservoir Debris Basin; and development of a comprehensive Capital Improvement Program; and

WHEREAS, Ms. Abel has been a strong advocate for the Cachuma Project water rights of the member agencies of CCRB and their endeavors to maintain a balanced program for water supply reliability and protection of fisheries resources downstream of Lake Cachuma, particularly with her lobbying efforts to bring federal grant funds for steelhead to California, and with the installation of gate extensions on Bradbury Dam, to allow storage of an additional 9,200 acre feet of water for the downstream fishery; and

WHEREAS, Ms. Abel has brought her regional perspective, her wisdom, and her dedication to make well reasoned and important decisions for the overall benefit of CCRB and COMB.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors and staff of the Cachuma Operation and Maintenance Board and the Cachuma Conservation Release Board extend to Jan Abel their sincere appreciation and heartfelt thanks for the invaluable service that she has given to the Boards, its staff and to the people of the County of Santa Barbara.

Ms. Rees reported that the COMB Board has had a recent change in two of its Directors, Lee Bettencourt replaced Matt Loudon from the Santa Ynez River Water Conservation District and Doug Morgan replaced Jan Abel from the Montecito Water District. The adoption of Resolution 498 and 499 will add these two Directors as a signatory on the COMB Renewal Fund and Trust Fund Accounts and on the COMB General Fund Account at Santa Barbara Bank & Trust.

Director Lieberknecht moved to approve and adopt Resolutions No. 498 and 499, seconded by Director Hanson. A roll call vote was taken, passed 7/0/0.

Director Morgan requested that the metering issue in the lower reach be resolved. Ms. Rees stated that there would be a meeting probably in February to address the issues.

b. Operations Report

The Operations Report was included in the board packet

c. COMB Operating Committee

The draft minutes from the January 13, 2010 meeting were included in the board packet.

Rebecca Bjork stated she felt the minutes reflect an accurate representation of what was discussed at the meeting. She wanted to point out that the letter from ID #1, which was distributed during the Board meeting, described actions that were not actually taken. The intent of the Operating Committee was to allow the managers to discuss issues before those issues were presented to the Board. She reiterated that the issue with the proposed Meadowlark project was a perfect example of the Operating Committee functioning as it was intended to. The committee felt this project was not an appropriate project for either COMB or CCRB to undertake. The ID #1 letter mischaracterizes what actually happened at the Operating Committee meeting concerning the Meadowlark project and the ownership and maintenance contract for the fish projects with the county. No action was taken on either item and these items will not be considered by the COMB Board.

Chris Dahlstrom spoke to the COMB Board regarding the concerns of the ID #1 Board of Trustees and why President Buchardi wrote the letter objecting to COMB's involvement in the Meadowlark project as well as the it's involvement in negotiating a contract with the County for the ownership and maintenance of the Fish Projects.

d. Quagga Mussel Inspection Report - County of Santa Barbara

The monthly report from the County of Santa Barbara was included in the board packet.

Director Hanson reported that the Quagga Ad Hoc Committee has not been able to schedule a meeting with the County Board of Supervisors.

e. Jesusita Fire Activities

The final report for the Jesusita Fire activities was included in the board packet. Director Morgan requested that cost for the different activities be included in these reports.

Ms. Rees reported that there had been no change in the status of the Cachuma Lake Resource Management Plan and EIS (RMP/EIS). The completion date is now anticipated for January 2010. A certified EIS is also necessary for the long term lease negotiations to proceed.

g. Proposition 50 and 84 Activities

Ms. Rees had reported at the December meeting the SWRCB had suspended reimbursement to the Santa Barbara Prop 50 region. Included in the board packet was the corrective action letter sent to the SWRCB from Santa Barbara County Public Works Department. The State Board considered the actions and Ms. Rees has recently received information that the State Board has accepted the County's corrective actions and the reimbursement suspension will soon be released.

Ms. Rees reported that she hopes to bring to the Board in February a new MOU for Prop 84 that will be considered for the distribution of the administrative costs for continued work on Proposition 84 grant applications.

A letter to the COMB Board from the Board President of Santa Ynez River Water Conservation District, ID #1 was distributed at the meeting. The letter stated that the ID #1 Board determined in a unanimously approved motion that it would defer and withhold its action on the COMB Bond Resolution until such time that an

amendment is made and approved to the COMB JPA. The amendment needs to state and clarify that COMB is precluded from performing or engaging in any and all activities in the Santa Ynez River downstream of Bradbury Dam, and any and all Cachuma Project or water rights matters that affect downstream interests. Also, a clear demarcation between COMB and CCRB must be re-established.

Director Williams moved to table Item #8 to the February Board meeting, seconded by Director Morgan, passed 7/0/0.

Director Morgan questioned the timeline of the two projects and if they were up to date. Ms. Rees said that it would be looked at but that she thought they were up to date.

10. Consider Approval of COMB Operations Staff Restructuring and New Engineer Position

Ms. Rees reported on the Operations staff restructuring. She recommended that the Operations Supervisor's job description be revised to shift a few higher level duties to a new engineer position. Along with the revised job description would be a lower salary range for the Operations Supervisor position. She requested the Board approve the permanent appointment of Robert Dunlap to Operations Supervisor and eliminate the Operations Foreman position.

Ms. Rees also requested approval to hire a new professional Engineer at a commensurable salary range. The fiscal impact for FY 2010-11 will be an increase in operations salaries for a total of \$17,852. To offset the increase in salary, staff will reduce other areas of the COMB budget, primarily in outside consulting work.

Director Hanson moved to approve the staff recommendations with the addition of Director Morgan's request that Robert Dunlap be given an evaluation, that the Operating Committee be able to look at the top engineer candidates, inform the Board of the selection committee when it has been formed and to consider Bob Roebuck to fill the position possibly as a half time position The motion was seconded by Director Morgan and passed 6/1/0. Director Lieberknecht voted no.

11. Ad Hoc Committee Report Regarding COMB Operating Committee's Role and Responsibilities

Director Williams reported on the COMB Operating Committee's Role and Responsibilities as discussed during the January 13th Operating Committee meeting.

A wide ranging discussion took place regarding the structure of the Operating Committee:

- Which issues should first be considered by the Operating Committee and which should first go directly to the Board or the Board CIP Committee
- Return to a more informal Managers meeting, so that both COMB and CCRB items could be discussed
- Strive to develop the model of the CCWA Operating Committee
- Including fisheries projects discussion at the COMB Operating meeting
- Fisheries work would be discussed at a separate meeting on an ad hoc basis, including attorneys as needed
- Continue the current Operating Committee structure dealing with COMB issues only
- Do fisheries projects involve water rights or do they not

Director Hanson moved to recommend that the COMB Operating Committee would address COMB issues and that there be a separate managers meeting taking place on an ad hoc basis, including the attorneys as needed, to occur before or after the Operating Committee meetings. This meeting would be held to discuss fish project issues. Director Hanson included in her motion to add this item to the next CCRB agenda for consideration, seconded by Director Morgan, passed 7/0/0.

12. Consider Santa Barbara County Parks Department's Request for Assistance with Matching Funds for Cachuma Park Federal Grant and Request to Authorize issues Discussion with the County CEO's Office

This was thoroughly discussed during the CCRB meeting, Item #5.

Director Morgan moved to postpone the approval of allowing County Parks to use COMB/CCRB projects as matching funds for a federal grant application for the improvement projects at Lake Cachuma until COMB has an opportunity to speak with the County. He would like to authorize Ms. Rees to develop a list of unresolved issues, circulate it among the MU managers and ID #1, and would like for John McInnes to immediately initiate dialog with the County CEO's office to institute a collaborative process. Director Bettencourt requested that a representative from ID #1 be included on the committee that meets with the County, seconded by Director Hanson, passed 6/1/0, Director Bettencourt voted no.

13. Directors' Request for Agenda Items for Next Meeting

President Williams requested that an amendment to the COMB JPA to remove the Santa Ynez River Conservation District, ID #1 from the COMB JPA be considered.

Director Hanson requested that consideration of an amendment to the COMB JPA to revise the unanimous consent so that project approval would only require approval from the paying members.

Operations Report – January 2010

The average flow from Lake Cachuma into the Tecolote Tunnel for January was 37 acre-feet per day. Lake elevation was 730.57 feet at the beginning of the month and 738.31 feet at the end. 50 acre-feet of State Water Project water was wheeled through Cachuma Project facilities and delivered to South Coast Member Units during the month.

Conditions at Ortega Reservoir have remained consistent over the month, with weekly monitoring of drain flow, piezometer elevations and site conditions.

Other activities conducted this month include:

- Jesusita Fire recovery efforts at Lauro Reservoir during January continued with project development and planning for an oak tree planting and restoration program for Lauro Reservoir proposed to begin in March 2010.
- Initial site visits and planning for a South Coast Conduit Lower Reach Alignment and ROW study began in January.
- The landscaping contract for the Ortega Reservoir Cover Project was completed, and the termination of the contract consented to by Montecito Water District, COMB and Plowboy Landscapes, Inc.
- Progress continued on the 2nd Pipeline and Mission Creek projects. A complete status of the projects is included in the board packet for the February COMB board meeting.

Routine operation and maintenance activities conducted during the month included:

- Sampled water at North Portal Intake Tower
- Monitored conduit right-of-way and responded to Dig Alert reports
- Read piezometers and underdrains at Glen Anne, Lauro and Ortega Dams
- Read meters, conducted monthly dam inspections, and flushed venturi meters
- Weed abatement at Lauro Yard
- Quarterly calibration in January of all venturi meters on the Upper Reach of the SCC

Dan,

Regarding possible funding for quagga programs, long story short, FWS funding is going to broad application or state-wide urgent needs. The \$2 million that Congress allocated to FWS for quagga prevention is going toward specific, high-priority needs identified in the Quagga-Zebra Mussel Action Plan (QZAP) for Western US Waters, released last May. One angle would be for Parks to lobby DFG to go after FWS funding for inspection stations on roadways connecting Cachuma Lake to waterbodies to the south inc. San Diego, eg, 101 and T5.

Long story long:

The four "highest priority actions," included:

- --Implementation of inspection and decontamination stations at infested waters;
- --Dedicated state ANS law enforcement
- --A rapid response fund for containment at newly infested waters
- --Detection and monitoring programs

Further, the QZAP identified \$165 million needed annually to address these issues in the western states alone. So far, Congress has allocated a mere \$2 million to FWS.

In other words, the funding is being applied to urgent needs that will have broad application:

Research: studying the mortality efficacy of hot water wash; and studying how to improve laboratory detection of microscopic mussel larvae within water samples.

Roadside decontamination stations on roads leading to Lake Tahoe

Another portion will support <u>specific quagga and zebra mussel activities addressed in Aquatic Nuisance Species Task Force-approved State and Interstate ANS Plans.</u>

So, as I already mentioned, it's in our interest—and seems compatible with statewide ANS plans—to lobby DFG to go after FWS funding for inspection stations on roadways connecting Cachuma Lake to waterbodies to the south inc. San Diego, eg, 101 and I5.

Parks and Public Works did receive funding last year from USBR to purchase hot washers, signage, and outreach.

There are a couple important areas where we could beef up our program if we had funding:

1) Early Detection and Monitoring: Plankton tows to collect samples to examine for microscopic veligers. Samples would be sent to a lab equipped to detect them.

2) Public outreach:

- a. Production of a radio PSA to be used repeatedly, in different seasons and regions that would have applicability anywhere in the state of California. Not only would we benefit locally and regionally, further regions could then use the generic piece and arrange to air or purchase their own air time.
- b. Several timed mailings to our boater base to spread the word regionally to keep pressing to promote a paradigm shift in boater behavior and expectations. Boater education has an impact, there is no question on that count.

I'll put out inquiries for smaller pockets of money to my contacts in DFG and elsewhere. I also will inquire whether there are more recent funding opportunities from USBR.

Minutes from January 7, 2010 Member Agency Review Meeting

Per your December 2009 request, AECOM prepared for and attended a meeting on January 7, 2010 to discuss Member Agency review comments relative to the proposed Mission Creek Pipeline Relocation Project. We have the following comments:

- ▶ Review comments were requested to be submitted from the Member Agencies prior to the meeting; however no comments were submitted prior to the meeting.
- ▶ Written review comments were provided by the Goleta Water District during the meeting (copy attached). The following are our responses:
 - 1. Sheet C-1 AECOM will modify the profile to clarify that "designed" centerline of the SCC does not match the as built centerline of the pipeline shown.
 - 2. Sheet C-5 Damage to the temporary pipe support due to flood flows should not be an issue (concern) because the pipeline construction has to be completed prior to the wet season.
 - 3. Sheet C-7
 - a. The design of the blow-off discharge pipe will be revisited as requested.
 - b. The MH drain detail will be revised as requested.
 - 4. Sheet C-8
 - a. Elevations will be added to details 1 and 2.
 - b. Piping configuration has been confirmed with COMB, therefore no revisions are anticipated.
 - 5. Sheet D-2 Detail 1 will be revised to reflect the more recent design of the profiles (Sheets 7 and Questa Profile drawing).
 - 6. Sheet D-5 Thrust block comments were discussed and then resolved in the meeting. No revisions required.
 - 7. Sheet D-6 Confirmed, all new pipe joints are restrained (welded).
 - 8. Questa Plan/Profile Sheet Size of boulders have been increased based on review comments from permit agencies.

- 9. Questa Roughened Channel Profile Sheet Will add second cut-off wall as requested.
- ▶ Miscellaneous Comments Discussed During the Meeting:
 - 1. Pipeline Relocation to Avoid Any Impact to the Streambed: During the concept development phase of the project, the Project Team (COMB, Civil consultant (AECOM), and CEQA consultant (SAIC)) conducted a "constraints analysis." The analysis concluded:
 - a. The pipeline could not be realistically relocated without impacts to the streambed (bank to bank).
 - b. Any impact to the stream bed would result in regulatory permit requirements inclusive of Department of Fish and Game Streambed Alteration and NMFS Biological Opinion.
 - c. The regulatory permits would require removal of the existing pipeline.
 - d. The existing concrete above the pipeline is a barrier to fish passage.
 - e. Revised horizontal alignments would require substantial additional easements.
 - 2. Pipeline Located on Another Alignment: The base concept to remove this section of the SCC and replace it with a new pipeline section on the same horizontal alignment was selected well over two years ago. The concept is clearly described in AECOM's 2008 proposal for engineering services which was authorized by COMB and available to Member Agencies. The concept was also clearly noted in the 2008 Initial Project Report for the Reliability Program which was distributed to all Member Agencies. The concept was clearly stated in the documents for CEQA compliance, permit applications, and right-of-way acquisition which have also been available to Member Agencies. Extensive effort and costs were not expended on alternative alignments or aerial concepts, as they were determined early on to be either infeasible, have as great or greater environmental impact, and not be cost effective. On January 7, 2010 COMB, AECOM, SAIC, and the City of Santa Barbara met to revisit the conclusions of the initial constraints analysis. SAIC and the City of Santa Barbara strongly confirmed that any permit process will require removal of the existing pipeline (barrier). AECOM confirmed that the magnitude of cost of the project would easily "more than" double if the pipeline was to be relocated without any impact to the streambed and adjacent "eco-sensitive" areas. The proposed alignment and profile is clearly the most overall cost effective approach given the primary constraint that the existing pipeline (barrier) will be removed.
 - 3. Temporary Pipe with Intermediate Pipe Support: The pipe "span" is not edge of bank to edge of bank, but between the points where the pipe is supported. Heavy wall pipe and cable/truss supports and associated foundations result in a higher cost than the standard pipe with a relatively simple intermediate support.
 - 4. Stability of Restored Stream Bank: Questa will be requested to confirm the design for stability of the disturbed sections of the stream banks.

RE: COMB BOND AND COMB ACTIVITIES IN THE SANTA YNEZ RIVER

Dear Directors,

At the Santa Ynez River Water Conservation District, Improvement District No. 1 ("ID No.1") Board meeting on Tuesday night, the Board of Trustees received a report from its General Manager concerning COMB's continuing and expanded activities in the Santa Ynez River below Bradbury Dam. Based on written documentation provided by COMB, these latest activities involve the Meadowlark Project and a proposed agreement between COMB and the County of Santa Barbara ("County"). As understood from the information provided at the COMB Operating Committee meeting, COMB has made certain financial arrangements and commitments with a private mutual water company and a private property owner in the Santa Ynez Valley to undertake the removal of certain private facilities within and crossing the Santa Ynez River. As to the second matter, COMB has engaged the County in negotiating a contract for the ownership and maintenance of the roadway, culvert, and streambed improvements of the Quiota Creek Bridge Crossing 6 Project ("Fish Project"). To complicate matters, CCRB personnel negotiated the financial arrangements and commitments on behalf of COMB.

Following a significant and lengthy discussion, the ID No.1 Board has found these most recent COMB actions highly objectionable for several reasons, as should the Board Members of COMB and CCRB since each is a separate and distinct organization. First, COMB's stated reason for the proposed Meadowlark Project is to remove a private culvert facility within the Santa Ynez River channel since it "poses a flooding hazard and a partial fish migration barrier." That premise is clearly outside the scope of COMB's charge under its JPA. Additionally, COMB

² CCRB personnel are actually COMB employees but are under a verbal contract with COMB to provide one hundred percent (100%) of their services for CCRB, except for the general manager's time which is allocated between the two agencies. made a financial commitment, utilizing its member agency's funds, as part of a grant, to pay in advance for this project for the benefit of private property owners that would have otherwise been responsible for those costs, which amounts to a gift of its public funds – a violation of California law. Finally, and equally as troubling, ID No. 1 does not understand how COMB can undertake such a project without prior authorization, direction or approval from the COMB Board. As such, it would appear that COMB staff prematurely and inappropriately committed COMB to this project, which is not binding on ID No.1.

With regard to COMB engaging the County in negotiating a contract for the ownership and maintenance of the Fish Project, no reason has been presented that would justify COMB's involvement or purpose for entering into permanent obligations for a project that was neither needed nor funded by COMB. CCRB and ID No. 1 provided for the design and exclusive funding for the Fish Project. It is understood that CCRB then executed a purchase order for construction of the Fish Project³, which COMB was not involved in this project. After completion of construction, COMB had no interest in the Fish Project, as ownership or otherwise, as no such interest was transferred to COMB⁴. As result, COMB does not have the authority to negotiate with the County for something in which it does not have an interest. ID No. 1 will not accept any responsibility for the County road right-of-way or maintenance of the creek channel to stabilize the roadway, and that it would not otherwise be contractually bound to maintain. The arrangements with ownership and maintenance of the bridge and streambed improvement should have been negotiated prior to construction, not afterwards, thus avoiding the current situation.

ID No. 1's greater concern is that COMB is now pursuing projects outside its authority, in the Santa Ynez River and which involve the water rights of COMB's member agencies. The Meadowlark Project is an egregious example of COMB proposing to undertake a project that could adversely affect ID No. 1's water rights⁵. COMB undertaking projects downstream of Bradbury Dam in the Santa Ynez River and its tributaries creates serious concerns which cannot and will not be tolerated by ID No. 1. Any further consideration of this project by COMB may lead to investigation, and possible action, to bring COMB into compliance with its JPA, in addition to ID No. 1 asserting its interest as necessary to protect its water rights.

The above activities underscore a larger issue and continuing concern that the ID No. I Board has raised in the past regarding activities undertaken by COMB and CCRB without regard to ID No. I's partnership participation in the fisheries projects. The recent Fish Project is indicative of the problem. ID No. 1 was precluded from the joint decision-making process in two respects: First, CCRB acted as if ID No. 1 and CCRB were not in a partnership to carryout the projects

³ CCRB's entered into this P.O. for construction of the Fish Project without CCRB carrying liability insurance, something that could have easily been cured by CCRB acquiring such insurance. Apparently CCRB did not need insurance for the numerous fish projects it previously constructed. ID No. 1 objected to the cost overruns that occurred during construction that were approved only by CCRB without change orders.

envisioned by the Biological Opinion; and, second due to the unilateral assignment, over the objection of ID No. 1, of this project from CCRB to COMB. This process that recently ensued was not envisioned in the 2001 MOU signed by CCRB and ID No.1 which provides for joint decision-making through a partnership for fish project approvals, funding and construction.

ID No. 1 has and desires to continue to work cooperatively with COMB and its member agencies on projects and programs within the purview of COMB. However, COMB must reciprocate that same level of cooperation by performing its activities within its JPA. COMB's disregard for complying with its JPA and disrespect for ID No. 1's representative on the COMB Board, coupled with the COMB undertaking activities with the Meadowlark Project has brought this matter to a head and will not be tolerated. As a result, the ID No. 1 Board determined in a motion, which was unanimously approved, that it would defer and withhold its action on the COMB Bond Resolution. The deferral of the Bond approval action will be effective until such time that an amendment is made and approved to the COMB JPA which clarifies that COMB is precluded from performing or engaging in any and all activities in the Santa Ynez River downstream of Bradbury Dam, and any and all Cachuma Project or water rights matters that affect downstream interests. Also, a clear demarcation between COMB and CCRB must be re-established and re-defined immediately to provide for a clear distinction between the two organizational structures, to separate the current commingling of the two agencies management and staff, to eliminate the overlapping and misappropriation of resources, and adhere to the existing JPA for each agency to allow for each agency's proper operation and administration. The motion also included that the COMB Board agendize the amendment to the JPA at its next COMB Board meeting. Once the above matters are accomplished, the ID No.1 Board will schedule a special Board Meeting in early February to take action on the COMB Bond Resolution. If such an amendment to the COMB JPA not be acceptable, ID No.1 will formally request withdrawal from COMB.

The ID No. 1 Board sincerely regrets having to withhold its consent to the COMB Bond resolution, especially considering that it has taken so many months for the COMB member agencies to iron out their differences. However, COMB undertaking yet another fish project, without the approval of the COMB Board and without first talking with ID No. 1 (since the project is within ID No. 1's territory) is the straw that broke the camel's back. The ID No. 1 Board is hopeful that this problem can be solved immediately so that the other COMB member agencies can proceed with the COMB Bond funding and construction of the second pipeline project.

RE: COMB Bond and COMB Activities in the Santa Ynez River

Dear Mr. Burchardi and Trustees:

This is in response to your letter of January 22, 2010 concerning the action taken by the Santa Ynez River Water Conservation District, ID No. 1 (ID No. 1) Board at its January 19, 2010 meeting regarding the Board's decision to withhold its approval of COMB's bond issue for the South Coast Conduit Upper Reach Reliability Project (Second Pipeline Project). Before responding to your demands regarding changes to COMB's Joint Powers Agreement (JPA) and COMB's authority to carry out steelhead projects in the Santa Ynez River watershed, the many inaccurate statements and conclusions stated in your letter need to be corrected. The ID No. 1 Board was misinformed, purportedly by your General Manager, regarding the status of the proposed Meadowlark Project to remove debris in the Santa Ynez River, as well as the proposed ownership and maintenance agreement with the County of Santa Barbara for the recently completed Quiota Creek Crossing 6 Fish Passage Project.

Your letter states that COMB had made financial arrangements and commitments with a private mutual water company and a private property owner in the Santa Ynez Valley to undertake the Meadowlark Project. As the COMB Board was unaware of this project, your accusation intimates that COMB's staff made these commitments without Board approval. As discussed at COMB's January 25th Board meeting, and confirmed by other member units managers and COMB's General Counsel, all of whom were present at the Operating Committee meeting of January 13, 2010, this is simply untrue. Neither COMB's General Manager nor any other member of staff authorized this project to move forward, and that was made very clear at the Operating Committee meeting, and repeated at COMB's Board meeting. The project was presented as a proposal for preliminary review, discussion, and input from the managers prior to making any recommendation to the Board. Yet the ID No. 1's Board was told that COMB staff had unilaterally made such financial and project commitments on behalf of COMB. Such an accusation is egregious and defamatory, and will not be tolerated by this Board.

The "documentation provided by COMB" referred to in your letter was an unexecuted grant agreement signed by the Pacific States Marine Fisheries Commission (PSMFC) indicating its approval of a grant for this project should the COMB Board decide to authorize it. Neither the staff nor the COMB Board approved proceeding with this project or signed any contract obligating COMB. Based on the Operating Committee's discussion, the consensus was that it would be more appropriate for the Santa Barbara County Flood Control District, or the private landowners, or even ID No. 1 to carry out the project rather than COMB. Therefore, the project was dropped as far as COMB was concerned, and staff was requested by the Operating Committee to investigate these other possibilities, which they have done.

The actual facts, a landowner near the Meadowlark crossing contacted Tim Robinson to ask for his assistance in getting a grant and regulatory permits to remove abandoned pieces of concrete culverts and old railroad spurs from the Santa Ynez River on his property. Dr. Robinson agreed to look into it, and was successful in obtaining a grant from the PSMFC with funds provided from the California Department of Fish and Game's (CDFG) discretionary funds for steelhead improvement projects. CDFG grants are normally awarded only to public agencies or NGO's, therefore a proposal to have COMB contract for the Meadowlark Project was discussed with the Operating Committee. Minimal staff time was spent on the grant application, and the purpose was to engender good will with the landowners in the area, which can do nothing but help the member units in carrying out the mandatory Biological Opinion requirements.

CDFG was of the opinion that the debris in the river was a potential steelhead passage impediment and flood hazard. In addition if the culvert pieces or railroad spurs were to break loose during high flood flows, they could cause damage to public structures downstream, including to ID No. 1's 4 cfs well field. Therefore, public benefits would be realized by removing this debris, negating your opinion that if COMB were to undertake this project it would amount to a gift of public funds to the landowners as well as a violation of California law. This conclusion is completely unfounded.

COMB's General Counsel is of the opinion that COMB does have the authority to implement the tributary projects and fisheries activities in the Cachuma Project Biological Opinion (BO), as well as other projects beneficial to steelhead that present themselves to comply with the adaptive management component of the BO. The fact that ID No. 1 differs with this opinion is indicative of the many outstanding issues left unresolved during the failed attempt at reorganizing COMB's and CCRB's responsibilities, including better coordination between CCRB and ID No. 1. I have personally offered many times to continue those discussions, but there has been an unwillingness on the part of ID No. 1 to do so.

With regard to the proposed ownership and maintenance agreement for the Quiota Creek Crossing 6 Project, you were again misinformed. First of all, construction of this project was contracted through COMB, not CCRB. Therefore, COMB was involved with this project and does have an interest. It was partially funded by a grant from the California Coastal Conservancy using the remaining funds awarded to CCRB through Proposition 12 in 2000. However, the Coastal Conservancy was unwilling to provide the grant funds to CCRB without that agency having proper insurance coverage. There were a number of other administrative questions raised as well. Consequently, the CCRB and COMB Boards agreed it would be most expedient to have COMB enter into the construction contract for this project. An MOU was drawn up between CCRB and COMB (also a Coastal Conservancy requirement) to allow the CCRB grant to be used for the COMB project.

Because COMB held the construction contract, the County's encroachment permit was issued to COMB. Consequently, the proposed draft ownership and maintenance agreement was written between COMB and the County. This draft document has only been discussed on the staff level and has gone no further than the Operating Committee. It was drafted to be responsive to a request by the COMB Board and the member unit managers, and most by especially ID No. 1, to establish a procedure for determining ownership and maintenance of the fish passage structures. The Quiota Creek Crossing 6 Project is the first of these agreements to be addressed, and the intent is to use the ownership and maintenance agreement as a template for all projects on public property. The COMB Board has not seen it or approved it. Again, incorrect information was presented to the ID No. 1 Board unjustly accusing CCRB staff of negotiating financial arrangements and commitments on behalf of COMB.

The underlying issue here is ID No. 1's desire to keep COMB and CCRB activities completely separate, whereas the south coast member units have, for the sake of efficiency, carried out construction of the fisheries projects through COMB. After four years of discussion, these organizational conflicts are still not resolved. However, it is the opinion of COMB's General Counsel that COMB is acting within the powers of its JPA when implementing the fish projects identified in the Biological Opinion/Fish Management Plan EIR/EIS for which COMB was the CEQA lead agency (which was adopted by unanimous vote of the COMB Board). Therefore, COMB does not believe any amendment to the JPA is warranted.

COMB also desires to work cooperatively with ID No. 1, and has not excluded ID No. 1 from the decision-making on any of the fish projects. ID No. 1's representative has participated in all discussions and decisions by both CCRB and COMB, and is as fully informed as the other member unit Directors. The 2001 Fish MOU provides for joint funding and cooperation between CCRB and ID No. 1 in carrying out the fisheries monitoring program and tributary projects, but it does not require independent project approval by CCRB and ID No. 1, nor does it envision that either agency should have veto power. It also has no language that restricts COMB from implementing fish projects in the Santa Ynez River.

In closing, COMB's implementation of fish projects in the Santa Ynez River watershed has not affected ID No. 1's downstream water rights. More importantly, these projects have no nexus to the COMB bond or the 2nd Pipeline Project, for which ID No. 1 is not responsible. The 2nd Pipeline project is extremely important to the health of the South Coast Conduit (SCC) and to the south coast agencies funding it. ID No. 1 has repeatedly stated it will support whatever the south coast member units wish to do with respect to the SCC work, and that it would approve the COMB bond and the project with the proper indemnification. Everyone has worked very hard to assure that indemnification is in place to protect the ID No. 1 Board and its customers. It is, therefore, unconscionable that ID No. 1 would withhold its approval of a project vital to the south coast cities and communities and use its veto power for political gain. Especially in light of the fact that "the straw that broke the came!'s back" was non-existent.

Given the inaccuracies presented to the ID No. 1 Board, upon which the District's decision was based, and the fact that COMB has no authorizations or approvals to withdraw regarding the Meadowlark Project or the Quiota ownership and maintenance agreement, at the COMB Board meeting I asked that ID No. 1 retract its letter. Mr. Bettencourt refused indicating that the proposed Meadowlark project had little or nothing to do with ID No.1's demand that COMB be precluded from

ITEM # _______ PAGE ______6 carrying out any and all work in the Santa Ynez River downstream from Bradbury Dam. Rather ID No. 1 is attempting to use by its veto power over the 2nd Pipeline Project to force COMB to do what they want.

This matter remains unresolved, but COMB again requests that ID No. 1 retract its motion and approve the COMB bond resolution.

Re: COMB Bond and COMB Activities in the Santa Ynez River

Dear President and Directors,

The Board of Trustees for the Santa Ynez River Water Conservation District, Improvement District No. 1, ("ID No.1") considered the Nordman Cormany Hair & Compton ("NCHC") December 21, 2009 Memorandum. The NCHC analysis concluded that the Cachuma Operations and Maintenance Board ("COMB") is the proper agency to implement the fish passage projects and by doing so is not undertaking "a matter involving the water rights of a party." We have asked our legal counsel, Brownstein Hyatt Farber Schreck, LLP, to evaluate the NCHC memorandum and prepare a responsive analysis. A copy of their memorandum is attached for your review and consideration.

We believe that the COMB Board should reconsider its prior position on whether to implement fish passage or other projects related to the National Marine Fisheries Service 2000 Biological Opinion for the Protection of Steelhead. As more fully discussed in the attached memorandum, the NCHC analysis is incomplete and based on an incorrect understanding of the underlying facts, which lead NCHC to an incorrect conclusion. ID No. 1 is of the opinion that COMB does not have the power to undertake fish passage projects and, even if it does, that such projects require the unanimous approval of the COMB Board of Directors since they involve the water rights of the Cachuma Member Units.

ID No. 1 is puzzled by the other Cachuma Member Units' desire to start implementing fish passage projects through COMB rather than continuing to carryout the fish related activities through the joint arrangement between Cachuma Conservation and Release Board ("CCRB") and ID No. 1 pursuant to the 2001 Memorandum of Understanding ("2001 MOU"). Rather than continuing to debate whether COMB has the authority or should implement fish passage projects, ID No. 1 recommends simply returning to the historical arrangement between ID No. 1 and CCRB for carrying out fish related activities and adhering to the established protocol for administering, funding and supporting those activities. In doing so, COMB will avoid becoming

unnecessarily involved in these activities and can continue to focus on more pressing matters facing the other COMB member agencies regarding facilities on the South Coast such as the COMB Bond for and construction of the Second Barrel Project.

In order to assure that the fish related activities do not overlap into COMB at sometime in the future, ID No. 1 requests that COMB amend its joint powers agreement to either define fish related activities to involve the water rights of the parties or add fish related activities to the list of those matters which require unanimous consent. By agreeing to this simple amendment, we can all avoid the continued unnecessary expenditure of public money on something that should not have been made an issue in the first place. The Member Units can then return to working cooperatively pursuant to the 2001 MOU to implement the fish passage projects and undertake other activities to protect our water rights and supplies for the benefit of our customers.

ID No. I hopes that we can resolve this matter quickly so that we can return to addressing more important matters facing our respective agencies.

RE: Cachuma Operations and Maintenance Board Implementation of Fish Projects

The Cachuma Operations and Maintenance Board ("COMB") recently constructed the 2009 El Jaro Creek (Cross Creek Ranch) fish passage project at the request of the Cachuma Conservation and Release Board ("CCRB"). Until that point, CCRB and the Santa Ynez River Water Conservation District, Improvement District No. 1, ("ID No. 1) had been jointly responsible for carrying out all activities related to compliance with the September 2000 National Marine Fisheries Service Biological Opinion for protection of the steelhead fishery downstream of Bradbury Dam ("BO"). When approval of the above project was brought to the COMB Board for approval, the COMB Board Members approved COMB's construction of this project over the objection of ID No. 1's representative. Subsequently, at the request of ID No. 1, COMB directed its general counsel, Nordman Cormandy Hair & Compton ("NCHC"), to prepare an opinion whether COMB had authority to carryout such steelhead fishery restoration projects ("Fish Projects"). Our analysis of the NCHC's memorandum is summarized in this letter.

NCHC concluded that COMB is the proper agency to implement Fish Projects and that COMB contracting for construction of such projects does not involve the water rights of any member of COMB such that it would require the unanimous approval of COMB's Board Members in accordance with the amended JPA. We disagree with NCHC's reasoning which lacks support for many of their conclusions. In order to properly address the question posed to NCHC, it is necessary to look: at the contracts between the United States Department of Interior Bureau of Reclamation ("Bureau") and COMB; the COMB Joint Powers Agreement ("JPA"); the State Board orders related to the Cachuma Project; the memorandums of understanding that have been entered into to support the implementation of the BO; the Santa Ynez River Technical Advisory Committee Lower Santa Ynez River Fish Management Plan (FMP); the EIR/EIS for the BO; and, the activities of COMB, CCRB and ID No. 1 related to compliance with the BO.

I. The Contracts between the Bureau and COMB

NCHC states that the operational requirements of the BO are not specifically identified in the following two contracts: 1) Contract No. 14-06-200-5222R the Transfer of the Operations and Maintenance of the Cachuma Transferred Project Works dated March 1, 2003 ("Transfer Agreement"); and, 2) Contract No. 175r-1802R between the United States and Santa Barbara County Water Agency Providing for Water Service From the Project ("Master Contract"). On that basis alone, they conclude that there is nothing that precludes COMB from performing all of the obligations of the United States related to Cachuma Project operations, including the operational requirements of the BO.

First, the operational requirements of the BO are not within the scope of the Transfer Agreement, which is very limited as it only authorizes COMB to operate and maintain the Cachuma "Transferred Project Works" on behalf of the Bureau. Section 1(c) of the Transfer Agreement provides a very detailed definition of the "Transferred Project Works", which means those facilities appurtenances and property described in Exhibit A consisting of the Tecolote Tunnel and the South Coast Conduit System; related in-line control facilities, turnouts, and measuring devices; equalizing reservoirs, associated water level control devices, and water level recording instruments and appurtenant structures; except as otherwise provided within the Water Improvement Agreement No. 1-07-20-X0200 entitled "Cooperative Agreement for Additions and Alterations to the South Coast Conduit, Carpinteria Section," dated June 26 1981, as amended April 16 2002. In essence, these are the facilities necessary to transport water from the Cachuma Project to the South Coast Member Agencies, they do not involve any other aspect of the Cachuma Project. As support for their opinion, NCHC references section 8(a) of the Transfer Agreement which provides that the Contractor (COMB) shall, when operating and maintaining the Transferred Project Works or any part thereof, perform all valid obligations of the United States pertaining to the transportation, storage and delivery of water from, through, or by such Transferred Project Works. This provision is not a broad grant of authority for COMB to perform any act related to the Cachuma Project but is very limited to performing all obligations with respect to the Transferred Project Works." It does not provide COMB any authority to perform any activities related to other portions of the Cachuma Project or activities related to Fish Projects. The Transfer Agreement is strictly limited to the Transferred Project Works.

The Master Contract is an agreement between the Bureau and the County of Santa Barbara ("County"), COMB is not a party to it. The Master Contract establishes the obligations of the Bureau to supply water to the County and the County's right to receive water from the Bureau (the County has corresponding agreements with each of the Cachuma Member Units to receive water from the Cachuma Project). NCHC references Section 2, Term of Contract — Right to use Water, of the Master Contract to support their conclusion. However, this section provides no such support as it only establishes the term in which the County (and the Member Units) has the right to receive water from the Bureau. NCHC provides no other analysis of the Master Contract to support their conclusion.

II. The COMB JPA

The Joint Exercise of Powers Act provides that a joint powers agreement shall state the purpose of the agreement or the power to be exercised. (Cal. Govt Code §§6500 *et seq.*) The agreement shall provide for the method by which the purpose will be accomplished or the manner in which the power will be exercised. (Cal. Govt. Code § 6503.) In order to determine if COMB has the authority to implement the requirements under the BO, the JPA must be reviewed to determine if the purpose and powers of COMB encompass such activities. The NCHC analysis failed to consider whether COMB even had the authority to under take Fish Projects for the Member Units or otherwise.

Section 1.1 of the JPA states that COMB's purpose is as follows:

...[T]o provide for the rights to, the facilities of, and the operation, maintenance and use of the United States, Department of the Interior, Bureau of Reclamation project known as the Cachuma Project, including storage, treatment, transport and appurtenant facilities, and all necessary tangible and intangible property and rights. This Agreement is made for the purpose of providing authority for the financing of "costs" for the capture, development, treatment, storage, transport and delivery of water as provided in and pursuant to the Marks-Roos Local Bond Pooling Act of 1985, or otherwise. Each party's obligation hereunder is expressly limited only to

the appropriation and contribution of such funds as may be assessed pursuant to this Agreement or as the parties hereto may agree.

Section 3.1 of the JPA provides that COMB has the following powers:

The Cachuma Operation and Maintenance Board shall have the power generally to perform all acts necessary and convenient to the purposes of the parties, including, without limitation, any and all acts necessary to carry out fully, on behalf of each of the parties hereto, the provisions of those agreements of the parties referred to herein as the "Contract for the Transfer of the Operation and Maintenance of Cachuma Project" Contract No. 14-06-200-5222R (Transfer Agreement); the "Contract Concerning the Transfer of Operation and Maintenance of the Cachuma Project Works"; all renewals of Contracts No. 175r-1802, 175r-1802R and 175r-1802IR, all other agreements made, and to be made, between the United States, the Cachuma Project member units and all other agencies; and all steps required by such contracts, Federal Reclamation law, and the laws of the State of California to exercise the right of renewal(s).

The purpose of the JPA coupled with section 3.1, above, limit COMB's authority to act with respect to the Transfer Agreement, the Master Contact and other contracts with the Bureau. This section authorizes COMB to perform all acts required of the Cachuma Member Units related to specified provisions of these agreements. However, as mentioned above, the Transfer Agreement provision is strictly limited to the Transferred Project Works. On the other hand, Section 27 of the Master Contract prescribes that the Member Units are to undertake certain activities related to the Cachuma Project, including "restoration of any riparian and other habitat of the Santa Ynez River and its watershed which has been adversely affected by the project". Under section 3.1 of the JPA it appears that COMB would have the power to undertake those responsibilities of the Member Units but for the description of the Master Contract. Unlike the Transfer Agreement or other contracts listed in section 3.1 of the JPA, COMB's authority related to the Master Contract is limited by the words "all renewals of" Contracts No. 175r1802, 175r-1820R and 175r-1802IR. Consequently, COMB is only authorized to act for the Member Units with respect to renewals of the Master Contract.

III. The BO Involves the Water Rights of the Parties

The southern steelhead were designated as an endangered species in 1997. The Bureau subsequently initiated consultation with NMFS regarding the effect of the continuing Cachuma Project operations on steelhead and its critical habitat on the lower Santa Ynez River below Bradbury Dam. The result was a Biological Assessment ("BA") which described downstream water rights releases for steelhead and numerous fish passage and habitat conservation measures for tributaries and the mainstream. In 2000, NMFS issued the BO which was based on the BA and included specific reasonable and prudent measures and as well numerous projects involving water rights releases for fish, habitat enhancements and fish passage projects aimed at protecting steelhead. Reclamation and the Member Units then prepared the 2000 Fish Management Plan ("FMP") to implement the provisions of the BO. Consequently, the BO and MP

are directly related to the Bureau's operation of the Cachuma Project and the Member Unit's water rights¹ in the project.

The BA and BO are further and directly related to the Member Units water rights in the Cachuma Project. In 1994, the Bureau and the Member Units, among others, entered into a Memorandum of Understanding ("1994 MOU") for the collection of data, preparation of studies and the release of water from the Cachuma Project for fish. The State Board incorporated these requirements in its Water Rights Order 94-5. In turn, these studies formed the basis development of the BA and BO and were included in the FMP. As a result, these various requirements are directly related to the Member Units' water rights in the Cachuma Project and will directly impact the pending hearings before the State Board on the Cachuma water rights permits.

In their discussion, NCHC concedes that the flow releases required by the BO undoubtedly have an impact on water supply and that these requirements may be incorporated and even increased when the State Board makes its decision on the Cachuma water rights permits. They also admit that the State Board hearings do involve all of the Member Units' water rights. NCHC then reaches the erroneous conclusion that the construction of Fish Projects has no impact on a Member Unit's right to receive it allocable share of Cachuma Project water. If the flow releases have an impact on the requirements to be imposed by the State Board on the Cachuma permits, then the BO certainly involves water rights. Correspondently, is the BO involves those water rights, the other projects in the BO also relate to water rights.

The NCHC analysis advances a restrictive view of Fish Projects as if they were being carried out in isolation, which is not the case. The various Fish Projects and other requirements of the BA and BO were negotiated and developed as an integrated approach to protecting steelhead and clearly interrelated to one another². The Fish Projects and flow releases are part and parcel with each other and cannot be separated as if one existed without the other. If the Fish Projects are not implemented by the Member Units there is little doubt that their water rights will be directly affected as a result of non-compliance with the BO and at the hearings before the State Board regarding the Cachuma water rights permits. Consequently, it is patently clear that the BO and each of the projects in the BO involve, either directly or indirectly, the Member Units' water rights. If that were not true, there would be no reason for the Member Units to invest significant time and public funds to construct Fish Projects. The only reason the Fish Projects are being carried out by the Member Units is to protect their respective water rights which are at risk of being adversely impacted by non-compliance with the BO.

IV. 1996 and 2001 MOUs for Implementation of the BO

The 1996 Memorandum of Understanding for Cooperation in Research and Fish Maintenance ("1996 MOU") was entered into by CCRB and ID No. 1, among other parties, for the maintenance of fish below the Bradbury Dam and to carry out the necessary studies with respect to any Santa Ynez River fishery. The studies were to assist the parties to the 1996 MOU in working towards a long term agreement about the fishery below the Bradbury Dam. The parties subsequently entered into the 2001 Memorandum of Understanding to Support Implementation of the National Marine Fisheries Service Biological Opinion ("2001 MOU") to implement the BO and the FMP.

¹ Although the Bureau holds the legal title to the water rights in the Cachuma Project, the Member Units hold the beneficial interest in those water rights to use of the water. As such, NCHC correctly concluded that the Member Units' right to use the water for beneficial purposes is a water right.

² NCHC agrees that the flow releases and the steelhead enhancement projects were all negotiated as part of the BA and BO.

and to provide for the governance and funding of activities arising thereunder. NCHC failed to consider or analyze either of the important MOUs in forming their opinion.

The 2001 MOU expressly states that the administrative and monitoring support for the 2001 MOU shall be provided by CCRB and ID No.1 (Section 5). The term "administrative and monitoring support" includes project/construction management for physical projects carried out under the 2001 MOU. The 2001 MOU further provides that the parties intend to have the arrangements in the 2001 MOU operate as the primary forum for resolution of issues related to maintaining the fishery below Bradbury Dam (Section 12). As a result, the 2001 MOU clearly provides that CCRB and ID No. 1 are the agencies to implement the Fish Projects below the Bradbury Dam. COMB was not a party to either MOU. Further while CCRB and ID No. 1 have the authority to hire consultants and contractors to perform the work arising under the 2001 MOU, neither has the right to assign their obligations to another agency, such as COMB³.

In 2004, COMB certified the EIR for the BO and FMP⁴. The EIR indicated that the FMP/BO projects would be carried out by either the Bureau, COMB, CCRB and/or ID No. 1. If the parties to the 2001 MOU had wanted COMB to be involved in implementation of the Fish Projects, the parties to the MOU would have amended it. No such amendment ever occurred. Rather, the 2001 MOU still provides the institutional framework for implementation of the BO, with CCRB and ID No. 1 designated to provide administrative and monitoring support.

V. Custom and Usage

NCHC suggests that the parties' custom and usage should be looked at to interpret whether Fish Projects involve the water rights of any party such that unanimous consent would be required. Course of dealing, usage of trade, or course of performance may be used to explain or supplement the terms of a contract — even if the parties fully intend the written contract to constitute a final expression of their agreement. (Cal Civil Procedure §1856(c).) NCHC states that it has not been the custom or practice of COMB members to raise any question suggesting that the Fish Projects might have any impact on the parties' water rights. This statement is incorrect. ID No. 1 raised just such an objection when the other four COMB directors (representing the other member agencies) voted to have COMB construct the Cross Creek Ranch/El Jaro Creek fish project.

In addition, it is incorrect that COMB has previously entered into construction contracts for various fish passage enhancement projects and has overseen the construction of these projects in the past without obtaining the unanimous approval by the COMB Board. There have been six fish projects completed to date⁵, all of which were constructed by CCRB and ID No. 1, except the Cross Creek Ranch/El Jaro Creek fish project. One project out of six does not constitute "custom and usage" to support the NCHC conclusion. Rather, the parties' custom and usage shows that CCRB and ID No. 1 have been responsible for the fish projects - not COMB. As such, the parties' custom and usage is consistent with the terms of the 2001 MOU.

³ As discussed above, the COMB JPA does not provide it with the power to undertake Fish Projects.

VI. Environmental Impact Report/Environmental Impact Statement (EIR/EIS)

NCHC states that the EIR/EIS for the FMP/BO provides that COMB and the Bureau are responsible for implementing the Fish Projects specified by the FMP/BO. However, they are not the only agencies identified in the EIR/EIS that may fund and implement the FMP/BO projects. The EIR for the FMP/BO identifies the Bureau, COMB, CCRB and/or ID No. 1 as agencies that may fund and implement FMP/BO projects. According to the EIR, the determination on which agencies or combination of agencies will fund or implement an action is to be based in part on the funding sources and location of the project. The only agreement between the parties for funding and implementing the FMP/BO projects is the 2001 MOU. As such, the parties are bound by the 2001 MOU until modified.

NCHC then goes on to conclude that because the resolution certifying the EIR/EIS was unanimously approved by the COMB Board⁶ such certification amounts to approval of the projects stated in the EIR/EIS and satisfies the JPA requirement for unanimous approval in accordance with Section 1.3(h)(ii). NCHC is mistaken in their understanding of the scope of the COMB resolution certifying the EIR/EIS for the BO/FMP. Contrary to their statement, COMB's certification of the EIR for the FMP/BO does not constitute approval of each of the projects in the FMP/BO. Certification is limited to just that – certification of the EIR, nothing more, nothing less. Public Resources Code Guidelines § 15090 (emphasis added) provides:

- (a) Prior to approving the project the lead agency shall certify that:
 - (1) The final EIR has been completed in compliance with CEQA
- (2) The final EIR was presented to the decision-making body of the lead agency, and that the decision-making body reviewed and considered the information contained in the final EIR prior to approving the project; and
- (3) The final EIR reflects the lead agency's independent judgment and analysis.

As stated in Public Resources Code §15090 an agency must certify the EIR prior to approving the project which, in this instance was the FMP/BO. On November 22, 2004, in Resolution 416 ("Resolution"), COMB certified the program and project specific EIR for the FMP/BO and for certain specific projects that had been developed in sufficient detail to conduct an environmental review⁷. The only "project" approved in the EIR was the FMP and BO⁸. A review of the COMB EIR and the Resolution reveals that no there were no approvals of any specific projects identified in the FMP and BO. Even for the specific projects certified in the EIR, certification does not amount to approval of those specific projects. The project approvals are separate and distinct and require separate approval⁹. As such, even If COMB had the authority to implement the FMP/BO projects, which it does not, its Board would have to unanimously approve each one specified in the FMP/BO since they involve water rights of the Member Units.

⁶ COMB was chosen by the Member Units to undertake and certify the EIR for the FMP/BO, as a matter of convenience, since it was the only agency that comprised all five Cachuma Member Units.

The environmental review for the other projects was to be performed on a project-by-project basis and tiered off the program EIR/EIR for the Bo and FMP.

⁸ NCHC agrees that the COMB Board adopted and certified the final EIR for the FMP/BO and certain specific projects but only approved one project - the FMP/BO.

VII. Conclusion

In summary, we disagree with NCHC's conclusions and the reasoning used to support those conclusions. It is inappropriate for COMB to contract and oversee the construction of the fish passage projects absent an amendment to its JPA and unanimous approval of the COMB Board since the Fish Projects involve the water rights of the Member Units. Rather, such projects should be carried out by CCRB and ID No.1 as provided in the 2001 MOU.

- 2. Approve, in substantially the same form, the Montecito Water District (MWD) Contribution Agreement whereby MWD commits to self-funding up to 13.1% of the total costs for the SCC Upper Reach Reliability Project.
- 3. Approve the Indemnification Agreement for the COMB bond whereby MWD, Carpinteria Valley Water District (CVWD), and Santa Ynez River Water Conservation District, ID No. 1 (ID No. 1) will not be held responsible or obligated in any way for the COMB bond contractual obligations.
- 4. Authorize the sale of the bonds, but not until after construction bids are received and an award of contract is approved by COMB and the Member Units.

DISCUSSION:

This item was considered at the January 25, 2010 Board meeting but was deferred to the February 22, 2010 meeting as a result of the Santa Ynez River Water Conservation District, ID No. 1 withholding its approval of the COMB bond at its January 19, 2010 meeting. Per the COMB Joint Powers Agreement, any obligation or project undertaken by COMB for over \$1,000,000 requires a unanimous vote of the COMB Board and must also be ratified by each of the Member Unit Boards (see Agenda Item #7).

There have been many revisions to the bond documents and related agreements, however, consensus was reached among all agencies, and changes to the legal bond documents and agreements were approved as to form, with the understanding that all documents would be brought before those Member Unit Boards that needed to reexamine the documents for approval of COMB's bond issue. Since that time all documents in the form attached have been

reviewed and approved by all Member Unit agencies. (Please refer to the January 25, 2010 Board package for all documents under consideration for approval).

The changes to the previous documents reflect more of a change in the approach to the approvals for funding and construction of the Second Pipeline Project. Notably, the approvals will occur in two phases. Phase one is for all Member Units to approve COMB's issuance of bonds in the amount of \$11M and the Bond Indemnification Agreement, and for the COMB Board to approve the Preliminary Official Statement, Joint Participation Agreements with GWD and the City, all related bond documents, the MWD Contribution Agreement, and the Bond Indemnification Agreement. The COMB Board will also authorize the sale of the bonds, but not until after bids are received and the lowest bid is determined to be responsive and acceptable. This approval and authorization has been rescheduled for the February 22, 2010 COMB Board meeting.

Staff is recommending to wait to rebid the project until after the financial documents are approved and the bond issuance authorized. Once the new bids are received, if the lowest qualified bid is determined to be responsive and acceptable, Phase 2 will be for COMB to approve a second resolution to approve the Second Pipeline Project, approve award the contract to the apparent low bidder, execute MWD's Contribution Agreement in final form, and approve a Project Indemnification Agreement with ID No.1. COMB's approval of the second resolution is tentatively scheduled for April 27, 2010. Because the construction contract will be more than \$1,000,000, award of the contract must also be approved by all Member Units prior to COMB's approval or ratified after COMB's approval. Phase 2 approvals will be rescheduled for Board meetings during April 2010. Sale of the bonds for the 2nd Pipeline Project will occur after COMB and all Member Units have approved the lowest bid and the construction contract. It is anticipated that the bonds will be sold in May 2010. A Notice to Proceed will be issued as soon as the bond proceeds and MWD's cash contribution are received by COMB.

Joint Participation Agreements (JPA)

The JPAs for the City and GWD have been reviewed and updated. Each is now consistent with all other documents and they authorize the City's and GWD's financing of the Second Pipeline Project through the issuance of a COMB bond.

MWD Contribution Agreement

There were only minor revisions made to this agreement and the revisions did not change the intent or contractual obligations of MWD regarding self-funding its share of the Second Pipeline Project. The MWD Contribution Agreement is to be approved in substantially the same form by the COMB and MWD Boards at this time. The execution of the Contribution Agreement will occur following COMB's and the Member Units' approval the project and award of the lowest qualified bid by the COMB Board at the COMB April 27th Board meeting (date is tentative). MWD must also authorize execution of the Contribution Agreement.

Indemnification Agreement(s)

A change in direction was agreed to by all Managers and Attorneys regarding the Indemnification Agreement(s). The primary change was to have two Indemnification Agreements – one for the bond and one for the project. The Bond Indemnification Agreement will provide indemnification for all non-bonding agencies, namely MWD, ID No.1 and CVWD, from the bonding participants, which are COMB, the City, and GWD, for the issuance of an

\$11M COMB Bond. This new indemnification agreement will replace three separate indemnification agreements for MWD, CVWD and ID No.1.

The Project Indemnification Agreement will be between COMB and ID No.1 to indemnify ID No. 1 from any liability associated with the acceptance of the lowest bid, award of the construction contract, and construction of the Second Pipeline Project. The liability concern is valid and a separate agreement is justified as this project will cost in excess of \$1M. It will provide construction claim protection.

COMB Resolution 497

The COMB resolution authorizes COMB to proceed with the issuance of bonds for the Second Pipeline Project. However, they will not be sold until the following conditions have been met:

- The approval of an acceptable and responsive bid by all financially participating Second Pipeline Project agencies.
- The execution of separate resolutions by all Boards, including COMB, authorizing the approval of Second Pipeline Project construction project and contract.
- Approval of the Project Indemnification Agreement with ID No.1.

Approval Documents

The documents to be considered for approval today are attached and consist of the following:

COMB's Resolution 497approving the issuance of bonds for \$11M.

Preliminary Official Statement and all related legal bond documents.

Joint Participation Agreements with GWD and the City.

MWD Contribution Agreement, in substantially the same form, whereby MWD commits to self funding its proportionate share of the Second Pipeline construction costs.

Bond Indemnification Agreement indemnifying MWD, CVWD and ID No.1 from any financial contractual obligation associated with the issuance of the 2010A Revenue Bonds for the Second Pipeline Project.

RESOLUTION OF THE CACHUMA OPERATION AND MAINTENANCE BOARD AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$11,000,000 AGGREGATE PRINCIPAL AMOUNT OF REVENUE BONDS AND APPROVING THE EXECUTION AND DELIVERY OF CERTAIN DOCUMENTS IN CONNECTION THEREWITH AND CERTAIN OTHER MATTERS

- A. The Cachuma Operation and Maintenance Board ("COMB"), which was created pursuant to the 1996 Amended and Restated Agreement for the Establishment of a Board of Control to Operate and Maintain the Cachuma Project Cachuma Operation and Maintenance Board, dated as of May 23, 1996, by and between the Carpinteria County Water District, the Goleta Water District, the Montecito Water District, the Santa Ynez River Water Conservation District, Improvement District No. 1 and the City of Santa Barbara (as such agreement may from time to time be amended or supplemented in accordance with its terms, the "Joint Powers Agreement"), has determined to undertake the acquisition and construction of the South Coast Conduit Upper Reach Reliability Project (the "Second Pipeline Project").
- **B.** COMB has determined that it is desirable to issue revenue bonds ("COMB Revenue Bonds") to pay a portion of the costs of the Second Pipeline Project.
- C. COMB proposes to enter into Joint Participation Agreements with the Goleta Water District ("Goleta WD") and the City of Santa Barbara (the "City of Santa Barbara") which obligate such members to pay a percentage share of principal of and interest on the COMB Revenue Bonds.
- **D.** COMB proposes to enter into a Contribution Agreement with the Montecito Water District ("Montecito WD") which obligates Montecito WD to self-fund a percentage share of Second Pipeline Project costs.
- E. COMB is not proposing to enter into any financing agreement with the Santa Ynez River Water Conservation District-Improvement District No. 1 ("ID No. 1") or the Carpinteria Valley Water District ("Carpinteria VWD"), no amounts with respect to the COMB Revenue Bonds will be payable by ID No. 1 or by Carpinteria VWD, no amounts with respect to the Second Pipeline Project will be payable by ID No. 1 and Carpinteria Valley WD is currently not obligated to pay any amount with respect to the Second Pipeline Project.
- F. Goleta WD, the City of Santa Barbara, Carpinteria VWD, Montecito WD and ID No. 1 have each ratified the issuance of the COMB Revenue Bonds as required under Section 1.3 of the Joint Powers Agreement.

NOW, THEREFORE BE IT RESOLVED by the Board of Directors of COMB that:

1. The Indenture of Trust, in substantially the form attached hereto as Exhibit A and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President of the Board and Secretary of the Board or the General Manager of COMB are hereby authorized and directed to execute and deliver the Indenture of Trust with such changes, insertions and omissions as may be approved by the officer

The Contribution Agreement with respect to Montecito WD, in substantially the form attached hereto as Exhibit B and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President of the Board and Secretary of the Board or the General Manager of COMB are hereby authorized and directed to execute and deliver such Contribution Agreement with such changes, insertions and omissions as may be approved by the officer executing the same, including changes requested by rating agencies or bond insurers, said execution being conclusive evidence of such approval.
- 3. The Joint Participation Agreement with respect to Goleta WD, in substantially the form attached hereto as Exhibit C and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President of the Board and Secretary of the Board or the General Manager of COMB are hereby authorized and directed to execute and deliver such Joint Participation Agreement with such changes, insertions and omissions as may be approved by the officer executing the same, including changes requested by rating agencies or bond insurers, said execution being conclusive evidence of such approval.
- 4. The Joint Participation Agreement with respect to the City of Santa Barbara, in substantially the form attached hereto as Exhibit D and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President of the Board and Secretary of the Board or the General Manager of COMB are hereby authorized and directed to execute and deliver such Joint Participation Agreement, with such changes, insertions and omissions as may be approved by the officer executing the same, including changes requested by rating agencies or bond insurers, said execution being conclusive evidence of such approval.
- 5. The Purchase Contract with Citigroup Global Markets Inc., in substantially the form attached hereto as Exhibit E and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The General Manager of COMB is hereby authorized and directed to execute and deliver the Purchase Contract with such changes, insertions and omissions as may be approved by the officer executing the same, said execution being conclusive evidence of such approval; provided, however, that in no event shall the principal amount exceed \$11,000,000 nor shall the underwriting discount exceed 1.5% nor shall the net interest cost exceed 6% per annum.
- 6. The Continuing Disclosure Agreement with The Bank of New York Mellon Trust Company, N.A., in substantially the form attached hereto as Exhibit F and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President and the Secretary of the Board or the General Manager of COMB is hereby authorized and directed to execute and deliver the Continuing Disclosure Agreement with such changes, insertions and omissions as may be approved by the officers executing the same, said execution being conclusive evidence of such approval.
- 7. The preparation and distribution of the Preliminary Official Statement, in substantially the form attached hereto as Exhibit G, be and the same is hereby approved. The General Manager of COMB is hereby authorized to sign a certificate pursuant to Rule 15c2-12 promulgated under the Securities Exchange Act of 1934 relating to the Preliminary Official

Statement; provided, however, that such certificate shall not include a certification as to appendices relating to Goleta WD or the City of Santa Barbara. The President or Vice President of the Board or General Manager of COMB is hereby authorized and directed to execute, approve and deliver the final Official Statement in the form of the Preliminary Official Statement which, upon execution as authorized below, is made a part hereof as though set forth in full herein, with such changes, insertions and omissions as the officer or officers executing said document may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof. The underwriter is hereby authorized to distribute copies of said Preliminary Official Statement to persons who may be interested in the initial purchase of the Bonds and is directed to deliver copies of any final Official Statement to all actual initial purchasers of the Bonds.

- 8. The Board of Directors of COMB hereby authorizes the General Manager to select a municipal bond insurer to insure payments of interest on and principal of the Bonds so long as the General Manager determines that obtaining the municipal bond insurance policy provided thereby will result in a lower interest rate or yield to maturity on the Bonds. Bond Counsel is hereby directed to make all changes to the Indenture, the Joint Participation Agreements, the Purchase Contract, the Preliminary Official Statement and the Continuing Disclosure Agreement as are necessary to reflect the selection of a municipal bond insurer and the reasonable comments thereof.
- 9. The Board of Directors of COMB hereby authorizes the General Manager to select a municipal bond insurer to provide a reserve fund surety bond to be deposited into the reserve fund for the Bonds so long as the General Manager determines that obtaining the reserve fund surety bond will be cost effective to COMB. Bond Counsel is hereby directed to make all changes to the Indenture, the Joint Participation Agreements, the Purchase Contract, the Preliminary Official Statement and the Continuing Disclosure Agreement as are necessary to reflect the selection of a reserve fund surety bond provider and the reasonable comments thereof. The President or Vice President of the Board or the General Manager of COMB are hereby authorized to execute and deliver any customary agreement with the municipal bond insurer providing the reserve fund surety bond.
- 10. The Bank of New York Mellon Trust Company, N.A., Los Angeles, California is hereby appointed to act as Trustee under the Indenture of Trust.
- 11. The Indemnification Agreement, in substantially the form attached hereto as Exhibit H and, upon execution as authorized below, made a part hereof as though set forth in full herein, be and the same is hereby approved. The President or Vice President of the Board and Secretary of the Board are hereby authorized and directed to execute and attest such Indemnification Agreement with such changes, insertions and omissions as may be approved by the officer executing the same, including changes requested by rating agencies or bond insurers, said execution being conclusive evidence of such approval.
- 12. The General Manager, the President, the Vice President, the Secretary and any other proper officer of COMB, acting singly, be and each of them hereby is authorized and directed to execute and deliver any and all documents and instruments (including additional indemnification agreements) and to do and cause to be done any and all acts and things necessary or proper for carrying out the transactions contemplated by the Indenture of Trust, the Contribution Agreement, the Joint Participation Agreements, the Purchase Contract, the Continuing Disclosure Agreement, the Indemnification Agreement and this resolution.

- 13. Unless otherwise defined herein, all terms used herein and not otherwise defined shall have the meanings given such terms in the Indenture of Trust unless the context otherwise clearly requires.
 - 14. This resolution shall take effect immediately.

2nd Pipeline Project – Transfer to City of Santa Barbara

RECOMMENDATIONS:

- 1. Approve assignment of the Proposition 50 Subgrant Agreement to the City of Santa Barbara for construction of the South Coast Conduit Upper Reach Reliability Project (2nd Pipeline Project), contingent upon the final assignment agreement being acceptable to COMB's General Counsel, and authorize the General Manager, acting on behalf of COMB, to sign the assignment agreement once it is acceptable to both parties.
- 2. Authorize the General Manager, acting on behalf of COMB, to request a project assignment agreement between COMB and the Santa Barbara County Water Agency assigning COMB's Proposition 50 2nd Pipeline Project and all of its responsibilities under the Subgrant Agreement to a third party, the City of Santa Barbara.
- 3. Authorize the General Manager to take whatever steps are necessary to transfer all engineering designs/plans/specs, easement licenses, access agreements, permits, or other authorizations to the City of Santa Barbara for construction of the 2nd Pipeline Project.

DISCUSSION:

The 1996 Amended and Restated Agreement for the Establishment of a Board of Control to Operate and Maintain the Cachuma Project – Cachuma Operation and Maintenance Board (COMB JPA) contains a provision that requires a unanimous consent by the COMB Board and ratification by resolution by all parties to the Agreement for the issuance of bonds, notes, letters of credit or other indebtedness in excess of \$1,000,000.

On January 19, 2010, the Santa Ynez River Water Conservation District, ID No. 1 (ID No. 1) withheld approval of the COMB bond issuance for \$11.4 million to fund the construction of the 2nd Pipeline Project, unless the COMB Board agreed to amend its JPA to preclude COMB from carrying out any fish project or fish related activity in the Lower Santa Ynez River, and from any activity related to the water rights of the downstream interests. This action effectively stopped COMB from issuing the bond or constructing the 2nd Pipeline Project, even though ID No. 1 was not obligated to pay for any costs associated with the 2nd Pipeline Project.

The three Member Units who have agreed to fund the Project through COMB are the Goleta Water District (GWD), the City of Santa Barbara (City), and the Montecito Water District (MWD). These agencies are committed to funding construction of the 2nd Pipeline Project, which is essential to assure the continued reliability of Cachuma water deliveries to the south coast Member Units. In addition, if the Project is not constructed, \$3.2 million in Prop 50 grant funds will be lost, and COMB would be at risk with regard to meeting its contractual obligations under its Proposition 50 Subgrant Agreement with the County Water Agency and the Master Agreement with the State Water Resources Control Board (SWRCB).

Therefore, the City of Santa Barbara is considering issuing a bond for the full amount of this project with financial participation of GWD and MWD, and contracting for its construction. GWD and MWD Boards are currently considering this proposal, but preliminary discussions at the staff level indicate they would be interested in transferring the project to the City in order to get the 2nd Pipeline Project constructed.

For this to occur, several actions would need to be taken by the COMB Board, among them:

- 1) An assignment of the Project to the City would require a written assignment agreement between COMB and the City. The City must agree to assume all of COMB's responsibilities under the Prop 50 Subgrant Agreement, the MOU for grant administration, the IRWM Implementation Grant Agreement, and all related obligations. In return, COMB must assign its rights to reimbursement of project costs under those same agreements. If the GWD and MWD Boards agree to this proposed project transfer, an assignment agreement will be drawn up for approval by COMB and the City of Santa Barbara.
- 2) A project assignment agreement between COMB and the Santa Barbara County Water Agency assigning COMB's Proposition 50 2nd Pipeline Project and all of its responsibilities under the Subgrant Agreement to a third party, the City of Santa Barbara, would need to be executed between COMB and the County Water Agency. Once the assignment agreement between COMB and the City is executed, the County Water Agency Agreement can also be executed. The County Water Agency is not obligated to approve project assignments, and if not approved, COMB must complete the 2nd pipeline Project and pay \$5 million in matching funds. However, preliminary discussions with County Water Agency management indicated they would have no objection to this assignment. It is unknown at this time what, if any, approvals would be required by the SWRCB.
- 3) COMB would need to transfer all engineering designs/plans/specs, easement licenses, access agreements, permits, or other authorizations to the City of Santa Barbara for construction of the 2nd Pipeline Project. This is administrative and should pose no problem.

To facilitate the process and the needed approvals to transfer construction of the 2nd Pipeline Project to the City of Santa Barbara so that the Project can be constructed as soon as possible, staff is requesting broad authorization to sign and execute the necessary agreements on behalf of COMB, and transfer the engineering designs/plans/specs, easement licenses, access agreements, and permits, to the City as needed.

RE: COMB FY 2009-10 EXCESS BUDGET ASSESSMENTS

RECOMMENDATION:

- 1. Use excess budget assessments from FY 2009-10 to fund the SCC Delivery System Cost/Benefit Analysis authorized by the COMB Board for \$80,000.
- 2. Refund the balance of excess budget assessments to the Cachuma Member Units.

DISCUSSION:

Attached is a worksheet which outlines the budget assessments affiliated with the original annual \$1.1 million debt service, which is currently a line item in the COMB FY 2009-10 Budget approved by the Board in June 2009. Quarterly budget assessments have been made for the entire budget, including this line item, while waiting for the final outcome of the bond issuance.

Because the 2009 CIP Project is now just the 2nd Pipeline Project, and if COMB issues a bond for the Project, the debt service repayment will be reduced to approximately \$650,000 annually and will be paid by the Goleta Water District and the City of Santa Barbara only. Quarterly assessments for that line item have resulted in a disproportional excess of money collected. Assuming assessments for all four quarters, there would be about \$248,000 available to use for other COMB work.

Staff is proposing utilizing \$80,000 of the excess assessments to complete the SCC Delivery System Cost/Benefit Analysis. In July 2009, the COMB Board authorized a special assessment of \$80,000 to carry out the Cost Benefit Analysis to evaluate and determine if the current water entitlement cost distribution for COMB capital improvement projects is equitable, or if another cost distribution formula should be used in light of changes in the use of the SCC delivery system over time, capacity issues, and other potential inequities. This was to be done after the COMB bond was issued. However, given the long delay in approving the bond, it is recommended that this analysis move forward. The Operating Committee supports this proposed use of the funds.

Although there are other potential uses for the remaining funds, at the request of the Operating Committee it is further recommended that the balance of the excess assessments be refunded to the Member Units.
