Director Morgan referred to the minutes, item #6-a, regarding the receipt of formal confirmation from NMFS that the Quiota Creek projects for Crossings 2 and 7 will be covered under CDFG's Programmatic BO. Ms. Rees reported that NMFS would not respond in writing to COMB, however she would be writing up the minutes from the May 16th conference call and submit to all parties. Director Morgan requested that Ms. Rees include in the minutes that NMFS would not be responding with a formal letter regarding those issues.

4. Appointment of Secretary of the Board and ACWA/JPIA Alternate Representative

The Board Secretary and the alternate ACWA/JPIA representative were positions held by retiring General Manager, Kate Rees. Bruce Mowry has been appointed as the new General Manager and these positions should be held by him.

Director Morgan moved to appoint Bruce Mowry, COMB's new General Manager to serve as Secretary of the Board and to serve as the ACWA/JPIA Alternate Representative, effective July 1, 2011, seconded by Director Beebe, passed 5/0/2, Director Francisco was absent.

Due to the retirement of General Manager Kate Rees, the COMB Board has selected a new General Manager, Bruce Mowry. Adoption of Resolutions No. 522 through 528 will add Mr. Mowry as a signatory on the Renewal Fund, Trust Fund, General Fund, and the Revolving Fund Accounts at Santa Barbara Bank & Trust. It will also authorize Mr. Mowry to make financial transfers between the LAIF Account and the General Fund Account and/or the Revolving Fund Account at Santa Barbara Bank & Trust.

Director Morgan moved to adopt Resolution No. 522 through 528 relating to the COMB Bank Accounts, seconded by Director Lieberknecht, a roll call vote was taken, 5/0/2, Director Francisco was absent.

6. Reports From Board Committees

a. Reorganization Committee

Ms. Rees reported on the progress of the Reorganization Committee discussions. At the June 6th meeting they discussed the COMB JPA Amendment and the Implementation Agreement between ID#1, CCRB and COMB regarding certain sections of the 2001 Fisheries MOU. The agreements continue to be reviewed and when finalized will be ready for approval.

7. Consider Approval of Proposed FY 2011-2012 COMB Budget

Ms. Rees highlighted the proposed budget and reported that the main change to the budget since the Board reviewed it in May was a reduction in the SYR RiverWare Model Peer Review line item in order to accommodate ID No. 1's request to pay this cost through the Parent District. The proposed Final Budget consists of a gross budget amount of \$6,248,041 with projected offsetting revenues of \$3,119,718. These offsetting revenues include the Trust Fund/Renewal Fund monies, the Santa Barbara County Betterment Fund, two approved grants from the Department of Fish and Game a pending grant from NOAA, and a potion of the Proposition 50 Grant Funds. With the application of the offsetting revenues, the COMB Net Proposed Final Budget is \$3,128,323.

Director Beebe had several concerns from ID No. 1 that he requested be documented.

- Line Item 6206, Tri-County Fish Team, ID No.1 feels this support is not appropriate for COMB to fund.
- Line Item 6208 Legislative and Steelhead Funding Support, ID No. 1 feels this is not appropriate for COMB to fund.
- Line Item 5513 Cost/Benefit Analysis, ID No. 1 thought that this would be a study for the South Coast only and ID No. 1 would not pay for this study.
- Director Beebe stated that he was unable to track the numbers from the operations payroll and related expenses to the summary budget and requested a memo be sent explaining the process.
- Director Beebe requested an explanation of the \$15,000 paid for the genetic testing of tissue samples from the steelhead in the Santa Ynez River.
- Director Beebe made note that the Budget changed with the addition of relocation expenses for the new General Manager
- Director Beebe noted that the interest payment to the City had increased from \$10,000 to \$20,000, Janet Gingras, Administrative Manager said that she would look in to the difference but felt the \$10,000 was an estimate from a draft budget several months ago.

Ms. Rees explained that the Cost/Benefit Analysis would take a look at the overall cost distribution of all Member Units relative to their responsibilities to COMB and it was recommended that all Member Units share in the cost of this study.

Director Beebe moved to approve the COMB Proposed Final Budget for Fiscal Year 2011-2012, seconded by Director Morgan, passed 5/0/2, Director Francisco was absent.

8. Authorize General Manager to Approve Trust Fund/Renewal Fund 2012 Annual Plan and Five-Year Plan (MCA 27)

Ms. Rees reported that the annual meeting of the Cachuma Trust Fund/Renewal Fund Committee was held on May 25, 2011, the committee consists of Tom Fayram, County Water Agency and Kate Rees, Cachuma Member Units. The Fund Committee reviewed the plans and made suggested revisions. The funds will be used for the Lower Santa Ynez River Fisheries Program. The FY 2011-2012 funds are expected to total \$268,094 from the Renewal Fund and \$76,884 from the Trust Fund.

Director Morgan moved to authorize the General Manager, as a member of the Fund Committee, to approve the Warren Act Trust Fund/Cachuma Project Renewal Fund Five-Year Plan and the 2012 Annual Plan (MCA 27), seconded by Director Lieberknecht, 4/0/3, Director Beebe abstained and Director Francisco was absent.

9. Fisheries Division Activities

a. Fisheries Program Report

The monthly Fisheries Program Report was included in the board packet. Tim Robinson reported that there was very good flow during the month of May. The Adaptive Management Committee (AMC) did call for a 500 acre-foot AMA release from 5/14/2011 to 5/24/2011 to increase passage opportunities.

b. Report Updates

• 2008 Annual Monitoring Report

AMA Release Report

Tim Robinson had included a report on the 2011 AMA release in the board packet. An AMC meeting was held on 5/13/2011 to discuss the end of the spill, the presence of steelhead adults and migrating smolts within the LSYR, and the potential use of the AMA water to support downstream smolt and upstream adult migration. A release was scheduled over a 10 day period and that required 500 acre-feet.

• Backup documentation from the NOAA Science Center – Dr. Carlos Garza

At the Boards request, Tim Robinson had requested a letter from Carlos Garza, NMFS to confirm our agreement to collaborate on an ongoing basis with COMB, the genetic monitoring and evaluation of steelhead in the Santa Ynez River basin.

Tony Trembley, General Counsel recommended that the agreement should be looked at each Fiscal Year. He recommended sending a response letter stating that COMB has approved the expenditure for FY 2011-2012 but would evaluate the expenses every year.

c. Quiota Creek Projects Update

• Engineering Designs and County Encroachment Permit for Crossings 2, 7, and 1

Tim Robinson reported that final design work for Crossing 2 has been completed and that the plans will now go to the County, DFG, and NMFS for approval. Once the designs are final the Encroachment Permits will be approved and the bid packet can be prepared. Mr. Robinson is hoping to have the bid packet ready for the Ops Committee meeting July 6, 2011.

Director Beebe formally welcomed Bruce Mowry and requested that he review all designs for the Fisheries Projects and look into alternative project designs and report back to the Board.

The design work for Crossing #7 is 95% completed, however the grant application is still pending.

For Crossing #1 the County has increased the requirements of the project which will increase the cost of the project and require redesigning. The technical grant group's decision was that we should withdraw the applied for grant, redesign the project and reapply for a grant. Mr. Robinson was provided with information for 2 grant funding options for this calendar year.

• NOAA Grant Application for Crossing 7

The grant application is still pending, Tim Robinson reported that he should be receiving the status of the grant very soon.

• Bid Process

The bid packet will go before the Ops Committee and then to the Board for approval once the designs have been approved.

d. Tri-County Fish Team

• Public Forum Meeting, June 2, 2011

The agenda for the meeting was included in the board packet. Tim Robinson reported that there were two speakers at the meeting, one on potential restoration actions to enhance the ecological functions of the Lower Santa Ynez River Estuary and one on California Water Project.

• County of Santa Barbara Membership

The County of Santa Barbara is a signatory to the MOU funding obligation to TCFT.

• TCFT Revenues and Expenditures

Included in the board packet was a memo listing the participants in TCFT and their revenues and expenditures.

The Board requested that a discussion concerning TCFT funding mechanisms and the merits of COMB being a member be added to a future agenda.

Tom Fayram, County of Santa Barbara expressed his best wishes to Kate Rees upon her retirement.

10. Consider Approval of Letter Agreement for Funding and Administration of a Peer Review for the Santa Ynez River RiverWare Model

Ms. Rees reported that the Letter Agreement in the board packet supplements the one dated February 21, 2006 for the development of an updated SYR hydrologic model using RiverWare. The 2011 letter includes provision for funding a peer review process and also additional services for further development work as a result of the peer review. The parties to this Agreement include CCRB, COMB, City of Lompoc, City of Solvang, Santa Barbara County Water Agency, SYR Water Conservation District, ID#1, and Santa Ynez River Water Conservation District. Ms. Rees reported that CCRB approved the letter agreement during their meeting.

Director Beebe reported that ID No.1 had not had a chance to review the letter agreement and that they would be sending their comments to Bruce Wales, General Manger SYR Water Conservation District and agreed to COMB's approval in substantially the same form has presented in the board packet.

Director Morgan moved to authorize the General Manager to sign the letter Agreement among CCRB, COMB, Santa Ynez River Water Conservation District, Santa Ynez River Water Conservation District, ID No. 1, City of Lompoc, City of Solvang, and the Santa Barbara County Water Agency, in substantially the same form, for the purpose of peer reviewing the updated Santa Ynez River RiverWare Hydrology Model, including provision for further development work as a result of the peer review, seconded by Director Lieberknecht, passed 5/0/2, Director Francisco was absent.

11. Modified SCC Upper Reach Reliability Project

a. Consider Approval of Indemnification Agreement Between COMB and ID No. 1

Ms. Rees reported that the South Coast Member Units of the COMB Board have decided to construct a Modified SCC Upper Reach Reliability Project, and that ID No. 1 would not be held responsible or obligated for the project funding or any contractual obligations. The ID No. 1 Board approved the Indemnification Agreement on June 21, 2011.

Director Beebe moved to approve the Modified South Coast Conduit Upper Reach Reliability Project Indemnification Agreement between COMB and the Santa Ynez River Water Conservation District, ID No. 1, whereby ID No. 1 will not be held responsible or obligated in any way for the project funding or any contractual obligations, seconded by Director Morgan, passed 5/0/2, Director Francisco was absent.

b. Consider Approval of the Modified SCC Upper Reach Reliability Project Expenditure

Ms. Rees reported that because the Modified South Coast Conduit Upper Reach Reliability Projects exceeds \$1,000,000, COMB's Joint Powers Agreement requires a unanimous vote, staff requested Board approval for the Project not to exceed \$4,200,000. After COMB Board approval, ratification of COMB's action is required by all of COMB's Member Units.

Director Hanson moved to approve the Modified SCC Upper Reach Reliability Project not to exceed \$4,200,000, seconded by Director Lieberknecht, passed 5/0/2, Director Francisco was absent.

c. Update on Preliminary Work for Modified Upper Reach Reliability Project

An update on the Modified SCC Upper Reach Reliability Project was included in the board packet for information.

12. Operations Division Activities

a. Operations Report

The monthly report on Operations was included in the board packet. Jim Colton, Engineer reported that the computerized maintenance program has been implemented by the Operations crew and has been working very well.

RE:	SECRETARY'S ANNUAL STATEMENT OF INVESTMENT POLICY

The following is my annual statement of investment policy rendered pursuant to Section 53646(a) of the Government Code:

- 1. Investment of sinking fund or surplus money of Cachuma Operation & Maintenance Board (*Board*) shall be made in securities in which the Board is legally empowered to invest such funds in accordance with Section 53601 of the Government Code, taking into consideration the probable income as well as the probable safety of said funds, exercising the judgment and care under the circumstances prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not in regard to speculation, but in regard to the permanent disposition of said funds.
- 2. As far as possible, all money shall be deposited for safekeeping in state or national banks or state or federal savings and loan associations or may be invested as provided in Section 53635 of the Government Code.
- 3. Money may be invested in the Local Agency Investment Fund in accordance with Section 16429.1 of the Government Code.
- 4. No investments shall be made in financial futures or financial option contracts which are otherwise allowed pursuant to Section 53601.1 of the Government Code.
- 5. All interest earned shall be credited to the General Fund.
- 6. Accounts shall be established and maintained in Board accounting records to record surplus and inactive funds at all times in accordance with the State Controller's chart of accounts as authorized by Section 53891 of the Government Code.
- 7. Reserve Fund account balances shall be maintained separately and shall reflect at all times the balance in each reserve fund in a manner consistent with generally accepted accounting practices.
- 8. Depositories having custody of Board funds shall be directed to forward copies of all correspondence concerning Board funds to the Secretary of the Board.
- 9. Verification that monies have been on deposit at all times and collateralized in amounts equal to or in excess of funds designated by the Board of Directors as reserve funds shall be made in the annual audit of records.
- 10. After review and prior authorization by the Board of Directors, the Secretary should be delegated the authority and responsibility to invest or to reinvest funds of the Board or to sell or exchange securities so purchased in accordance with Section 53607 of the Government Code.
- 11. The Board should from time to time determine which reserve funds are surplus and which are inactive.
- 12. The Secretary shall render a monthly report to the Board in accordance with Section 53646(b) of the Government Code.

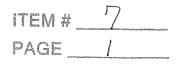

Tecolote Tunnel Seepage Study

June 20, 2011

The Tecolote Tunnel is used to divert water from Cachuma Reservoir to the South Coast. The proposed analysis would examine the nature of the tunnel infiltration. The tunnel infiltration would be evaluated to determine if the amount of seepage that occurs in the Santa Ynez River drainage portion of the tunnel can be distinguished from that occurring in the South Coast portion of the tunnel.

Task 1. Report and Data collection and Review

Obtain and review existing reports, geologic maps and data on tunnel seepage. There are several older reports that discuss tunnel seepage while the bore was constructed. These will be evaluated for the cumulative rate of flow with tunnel length. Other studies evaluated the decline in seepage as the groundwater system reached a new equilibrium. These will be evaluated for tunnel seepage records and changes in spring discharge on the surface. Historical and ongoing seepage data will be plotted and evaluated to determine if it can be used to assist in the analysis of the amount of flow with distance through the tunnel. Rainfall records will be used to evaluate the variability in seepage in relation to dry and wet cycles. Based on the work of Santa Ynez River Hydrology Committee (1985-1995), there is a correlation between annual rainfall and tunnel infiltration. The Committee also reduced the estimate of long-term tunnel infiltration of about 3,000 afy to about 2,000 afy after the drought of 1990's.

Task 2. Seepage Calculation

The information developed in Task 1 will be used to calculate or estimate the amount of seepage that occurs in the north and south side portions of the tunnel. If the data are inconclusive regarding the amount of seepage for each reach, an estimate of seepage on the north and south sides will be calculated from a recent average of seepage and proportioned to the length of the tunnel on each side of the drainage divide.

Task 3. Technical Memorandum

A technical memorandum will be prepared documenting the sources of data reviewed, results of analysis and the methodology used to apportion tunnel seepage to the north and south side drainages.

Cost Estimate

The cost beakdown for this study is enclosed.

Period of Study

It will take about a month to complete the study.

RE: June 2011 LOWER SANTA YNEZ RIVER FISHERIES REPORT

In compliance with the Cachuma Project Biological Opinion (BO) and as described in the Lower Santa Ynez River Fish Management Plan (FMP) and the Monitoring Program in the revised Biological Assessment (BA), the Cachuma Project Biology Staff (CPBS) conducts routine monitoring of steelhead/rainbow trout and their habitat on the Lower Santa Ynez River (LSYR) below Bradbury Dam. The following is a list of activities carried out by CPBS during the month of June 2011 that has been broken out by categories.

Snorkel Surveys:

Snorkel surveys are conducted at the end of the spring, summer and fall each year. The spring survey began in June and the data will be presented in next month's report.

Thermograph Network:

All thermographs were deployed at the beginning of June to record water temperatures at all designated locations within the LSYR mainstem and several tributaries. The units are downloaded monthly and the results are summarized in the Annual Monitoring Report.

Tributary Project - Crossing 2:

CPBS worked on obtaining final approval for the project design, the two outstanding permits and preparation of the bid packet. The project should be ready to bid by the third week in July.

Surcharge Water Accounting:

The following is a table of the amount of Surcharge water used to date from each of the three accounts. All numbers come from Reclamation's Daily Operations Report. The start time for the use of the Surcharge Water Accounts was 5/27/11, the last day the last was a full surcharge.

AGREEMENT BETWEEN THE COUNTY OF SANTA BARBARA AND THE CACHUMA OPERATION AND MAINTENANCE BOARD (COMB) FOR THE MAINTENANCE OF ROADWAY, CULVERT, AND STREAMBED IMPROVEMENTS AT REFUGIO ROAD CROSSING NUMBER SIX LOCATED 3.8 MILES SOUTH FROM HIGHWAY 246

This Cooperative Agreement (hereinafter "Agreement") is made this _____ day of _____ 2011, by and between the County of Santa Barbara, ("County"), a political subdivision of the State of California, and Cachuma Operation and Maintenance Board ("COMB"), a California Joint Powers Agency.

RECITALS

- 1. COMB is a California Joint Powers Agency formed by a 1996 Amended and Restated Agreement for the Establishment of a Board of Control to Operate and Maintain the Cachuma Project - Cachuma Operation and Maintenance Board. The members of COMB are the City of Santa Barbara, the Carpinteria Valley Water District, the Montecito Water District, the Goleta Water District and the Santa Ynez River Water Conservation District, Improvement District No. 1. COMB has contracted with the United States of America, Department of Interior, Bureau of Reclamation to operate and maintain the transferred project works of the Cachuma Project as defined in the contract.
- 2. COMB has undertaken the responsibility of improving fish passage in various areas of the Santa Ynez River and tributaries thereof, to assist the Bureau of Reclamation in complying with a Biological Opinion issued by the National Marine Fisheries Service pursuant to the Federal Endangered Species Act.
- 3. Specifically, COMB has performed fish passage improvements along Refugio Road where it crosses Quiota Creek
- 4. Refugio Road Crossing Number Six, located 3.8 Miles south from Highway 246 (Latitude 34° 33' 35.26"N, Longitude 120 5' 5.46"W), was a single-lane bridge with non-compliant railings. COMB has modified the road crossing through the installation of a bottomless arched culvert bridge to improve: (1) access and road safety for the traveling public; and (2) steelhead fish passage below the bridge in the streambed.
- 5. Refugio Road is listed on the County road inventory as a County-maintained road.
- 6. In the spirit of government-to-government cooperation, COMB and the County agreed to work together to facilitate fish passage and road repairs to Refugio Road where it crosses Quiota Creek, where feasible.
- 7. COMB undertook and successfully completed the construction of a bottomless arched culvert bridge and appurtenances on Refugio Road at Crossing Number Six (6) within the County road easement ("the Project"). The location and maintenance

responsibilities for the Project are set forth respectively in Exhibits "A" and "B" hereto, incorporated by reference herein.

- 8. The County issued COMB a conditional Road Encroachment Permit ("Permit") for the construction of the Project improvements referenced in the prior recital. A fully executed copy of County's Permit No. 040146 is attached hereto as Exhibit "C" and incorporated by reference herein
- 9. COMB also constructed and completed streambed improvements as a part of the Project, both inside and outside of the road easement below the bridge, as described in Exhibits A and B, respectively.
- 10. On date 1/23/09, the County officially signed off on and approved the Encroachment Permit upon successful completion by COMB of the Project on Refugio Road (See Exhibit D). The County acknowledges and agrees that COMB complied with all requirements of the Permit in constructing the Project and has no further obligations under the Permit. The County has now taken ownership of the roadway, bridge and embankment elements of the Project.
- 11. The County and COMB believe it is in their respective mutual interest to enter into this Agreement, to assign responsibility for ownership and future maintenance of various facets of the Project.

NOW THEREFORE, in recognition of an exchange of valuable consideration, the parties agree as follows:

I. ROADWAY AND CULVERT FACILITIES

The County accepts ownership of the roadway and culvert portions of this Project, which shall consist of the base material, asphalt, concrete structural section, bottomless arched culvert structure and associated structures such as wing walls, abutments, shoulders, guard-hand railings, graffiti proofing treatment, and graffiti removal. The County's maintenance responsibilities are depicted in Exhibit "B".

II. STREAMBED IMPROVEMENTS

COMB accepts ownership of the streambed improvements portion of the Project, which shall consist of weirs, rocks, rip rap, and other features placed in the streambed to facilitate fish passage. These items include present and future alterations of the streambed and weirs and other fish passage features or works, as required to maintain fish passage (consistent with the terms of any biological opinion issued by the National Marine Fisheries Service in connection therewith); stream erosion control; and vegetation maintenance or mitigation vegetation planting done in accordance with state or federal regulatory agency requirements.

Notwithstanding any provision to the contrary in Exhibit "B," COMB's maintenance responsibilities for the streambed improvements shall be limited to routine repair and

maintenance. In the event of flood damage which either destroys or in COMB's sole discretion significantly damages the project improvements, COMB shall not be obligated to repair or replace the improvements. Further, COMB shall not be responsible in any manner for general channel maintenance.

All notices required or provided for under this Agreement shall be in writing and delivered in person or sent by certified mail, postage prepaid, return receipt requested to the principal offices of the County and COMB. Notices shall be effective on the date delivered in person or on the date when the postal authorities indicated that the mailing was delivered to the address of the receiving party indicated below:

B. INDEMNIFICATION BY COUNTY OF SANTA BARBARA

VI. MISCELLANEOUS PROVISIONS

This Agreement, together with the exhibits, constitutes the entire understanding and agreement of the Parties. 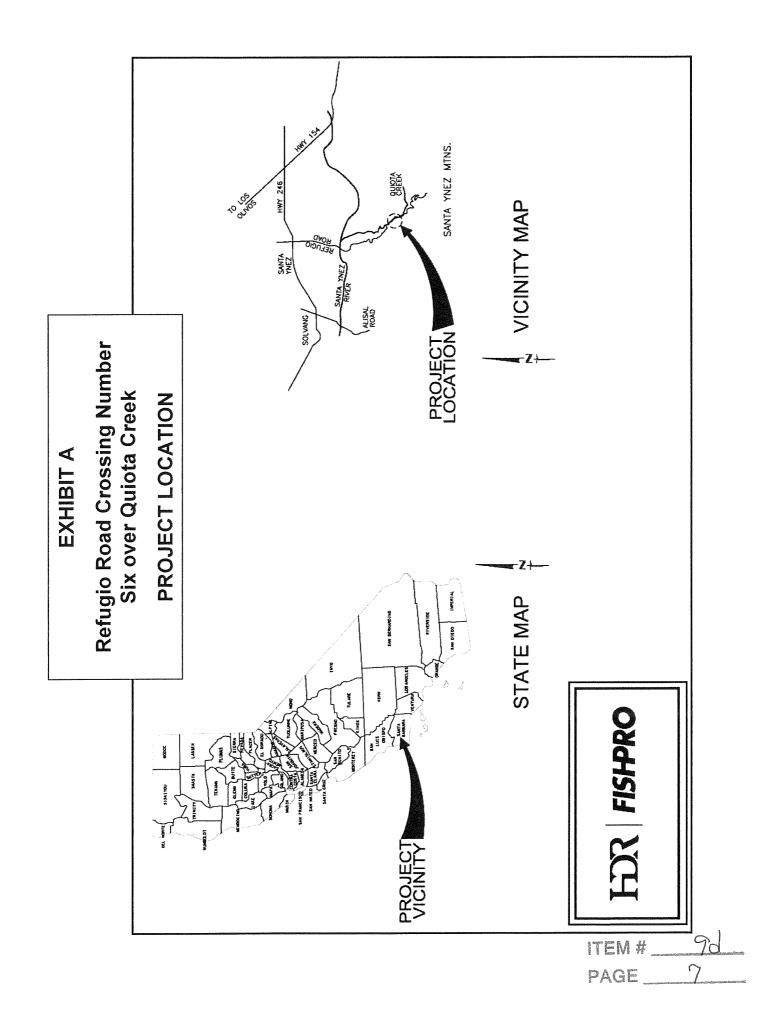

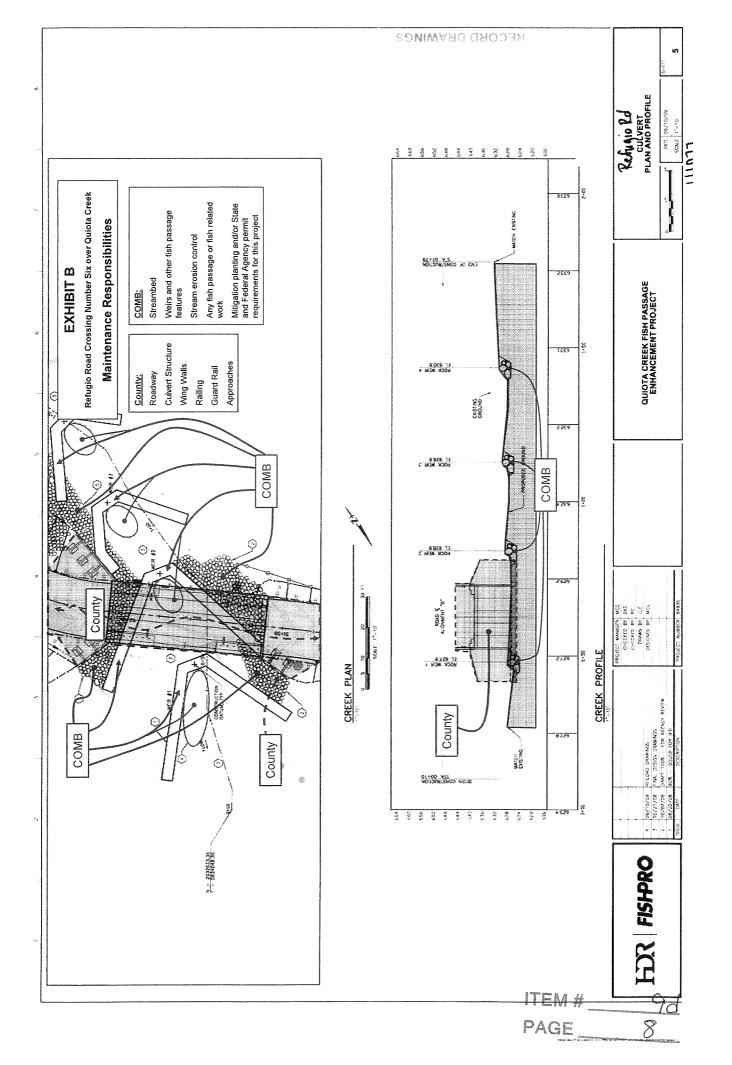

It is further agreed that if any facilities placed in the excavation or obstruction for which this application is granted and approved as a permit, shall become incompatible with future travel by the general public, then the applicant or its assigns or successors will, either remove such facilities in cases where such removal is necessary or in cases where the use thereof has been or is to be abandoned, or in other cases, applicant or its assigns or successors, will relocate such facilities at a location designated by the Commissioner, as provided in Section 30 and 30.1 of Ordinance No. 1491 of the County of Santa Barbara.

The provisions of the foregoing sentence shall not apply in any case where the easement for the facilities was in existence prior to the existence as such of the public highway concerned herein.

RE: Modified SCC Upper Reach Reliability Project Update

DISCUSSION:

Concept Design Phase

As directed by the Board, on July 19th, staff notified all member agencies that the draft Conceptual report for the Modified South Coast Conduit Upper Reach Reliability Project (MURRP) was available for review. COMB asked for comments to be returned no later than July 22nd as there are three parts (Preliminary Design, Design, and Bid Phase Service) with seventeen tasks outlined in Task Order No. 37 that need to be accomplished to stay on schedule. AECOM has been working on conceptual design refinement in preparation of a more specific project description to be used for permitting purposes and project planning.

Part 1, Preliminary Design Phase, includes concept design refinement, preliminary analysis, conceptual designs, and alternatives for consideration. Staff and member agencies will be very involved in this phase of the project, by providing valuable insight and oversight to the design team. These conceptual designs will be used to continue the permitting process. Property easement requirements will be revisited and compared to previously acquired locations. Additional surveys will be required at various locations along the proposed project as it differs from the 2nd Pipeline Project footprint.

After receipt of comments, AECOM will produce a final Concept Design Report.

Environmental Compliance and Permitting

The Concept Design Report from AECOM will determine the actions for any additional environmental compliance required for the MURRP. Although there will be no significant impacts likely to occur, further environmental compliance measures will be necessary for the project, in some capacity, regardless of the site specific detail in the Concept Design Report. An addendum to file to the 2nd Pipeline Project EIR will be necessary to identify changes to the original project for CEQA compliance, and will also be necessary for NEPA compliance. The nature of the addendum is dependent on the new Project Description identified in the Concept Design Report.

A Categorical Exemption will be required for the Air Vent and Blow Off Rehabilitation and for the Glen Annie/Goleta West Meter Rehabilitation work. If pipeline replacement is determined to be a necessary component of the project, a separate environmental analysis could be required by Reclamation referencing the 2nd Pipeline EIS for a NEPA specific analysis. Because replacement of sections of the SCC would be considered a new action under NEPA, this would trigger a NHPA Section 106 review of the project. Any pipeline replacement work will be on the existing SCC, and it is anticipated that due to the pre-disturbed nature of the soil substrate for the existing SCC alignment that no further Section 106 compliance will be required. Section 106 permitting and SHPO concurrence has already been completed for the South Portal Structure as part of the 2nd Pipeline Project.

Section 7 Endangered Species Act compliance may also be reviewed. However, this will be determined by Reclamation after review of the Concept Design Report and new Project Description. Additional compliance for the Section 7 consultation will be dependent on the location of any pipeline replacement section within riparian habitats. The South Portal replacement is substantially consistent with the existing EIS/EIR and Record of Decision, therefore may not need any further compliance.

Schedule

AECOM anticipated that the scope of services for the Design through Bidding Phases of the MURRP (excluding construction phase services) would be completed within 180 calendar days from the notice to proceed (May 11, 2010). Therefore, the attached schedule was pushed out by one month showing the Bidding Phase to end approximately in November 2011. The schedule has been adjusted to show completion of the project by January 2013 to comply with the SWRCB Prop 50 requirements.

Operations Report – June 2011

The average flow from Lake Cachuma into the Tecolote Tunnel for June was 81.5 acre-feet per day. The lake elevation was 752.94 feet at the beginning of the month and 752.50 feet at the end. The storage change was -1,331 acre-feet. "94" acre-feet of State Water Project water was wheeled through Cachuma Project facilities and delivered to South Coast Member Units during the month.

Ortega Reservoir was brought up to just below 18 feet of water (max depth 19.85 feet) and was inspected by a diver on July 18th and 19th. Daily toe drain readings were taken as the reservoir was brought up to elevation. Montecito Water District is preparing a resulting report.

Shane King (COMB Water Worker 1) has passed the Pesticide Applicators Professional Associates (PAPA) certification course. The Pesticide Applicators Professional Association is a California non-profit, public benefit corporation which is dedicated to providing Continuing Education to the implementation of safe and effective pest control techniques.

COMB has hired a new Water Worker I (David Flora) and an Engineering Technician (Megan Emami).

Other activities conducted this period include:

- O&M staff continues to use the newly computerized maintenance program to track progress on our aggressive structure rehabilitation and maintenance program on the South Coast Conduit structures.
- Staff has applied for a Biannual Caltrans permit to allow COMB to periodically work within Caltrans ROW to perform maintenance activities. COMB staff has completed traffic safety and flagging seminars and maintains a supply of traffic control devices.
- Staff continues to de-water Lauro Debris Basin as ground water infiltration continues to pond as much as one foot of water at the low point. Debris clearing is budgeted in the new FY 2011-2012 budget. Staff is attempting to dry out the basin as much as possible at this time. Staff will seek other competitive proposals to perform the work prior to proceeding.
- Staff continues to work on the Modified Upper Reach Reliability Project keeping reliability as the project premise. Staff will include member agencies in all meetings and copy on all correspondence.
- Staff has received final emergency SCC repair plans and specifications from AECOM. Specifications are being revised by COMB legal council to use a Master Contract format with General Requirements attached to complete the document. The goal is to secure materials on-site and coordinate the services of

at least four local contractors to be prepared in the event of a SCC emergency shut down or failure.

- Ninety five percent designs and specifications for vent structures and blow off modifications along the SCC as identified in the second Reliability Study have been received. These modifications are designed to reduce hydraulic constrictions in the system without significant system overstress. Three critical areas identified are: Barker Pass Vent Modifications, Return Pipe to Lauro Reservoir, and Sheffield Vent Modifications. The design package is pending funding but will be bid ready with only minor work in the future.
- COMB's next quarterly C.I.P. meeting will be held October 6th at 9:30 a.m. at the COMB office.
- The final Third Reliability Alternatives Study was delivered to COMB on June 13th. The document is located on an ftp site that is password protected.
- July 8th, 2011, staff received a copy of a letter from the Department of the Army to the State Historic Preservation Officer concerning the future Mission Creek Crossing Project. The Corps has requested concurrence on the adequacy of the historic property identification efforts and the finding of "no historic properties affected" for the proposed undertaking. The permit process is being kept active as it is very lengthy. A decision was made to finish the permitting process and put the Project on the "shelf" until funding is secured.
- Over burden conditions still exist on the Brown property. COMB continues to monitor the permitting process.
- A metal cover was installed over the dedicated inflow mag meter vault at Ortega Reservoir. The meter was also recalibrated and put back into service.
- Staff has raised a blow off structure with a four foot man hole extension ring located on Foothill road near Nidever Road in Carpinteria (see attached pictures). Staff rented an 8000 pound capacity lift to move the heavy structure on and off at location.
- TESCO Controls, Inc. replaced and reconfigured the existing SCADA backup system with computer hardware and software pertaining to the existing historical data server.
- On June 30, with COMB supervision, the California Department of Forestry (CDF) supplied a crew to clear debris off of the Ortega Dam face.
- Staff has researched and supplied past FEMA flood repair information to close out the books and receive final sign off.
- On July 13th, City of Santa Barbara TV was escorted to select locations to film elements of the SCC. The tour was permitted by the Bureau of Reclamation.

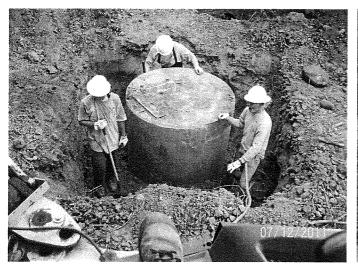

- Monitor cathodic protection at Lauro Yard (54" steel pipe)

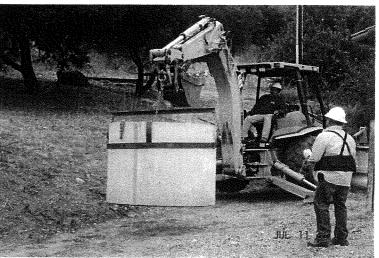

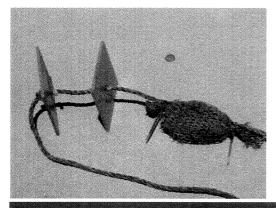


Cachuma Lake Marina Monthly Quagga Survey Map: Sampling stations and lines, docks, boat ramp, boathouse, logs

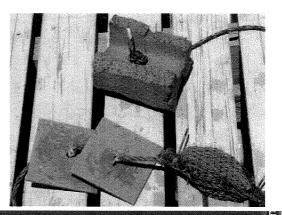

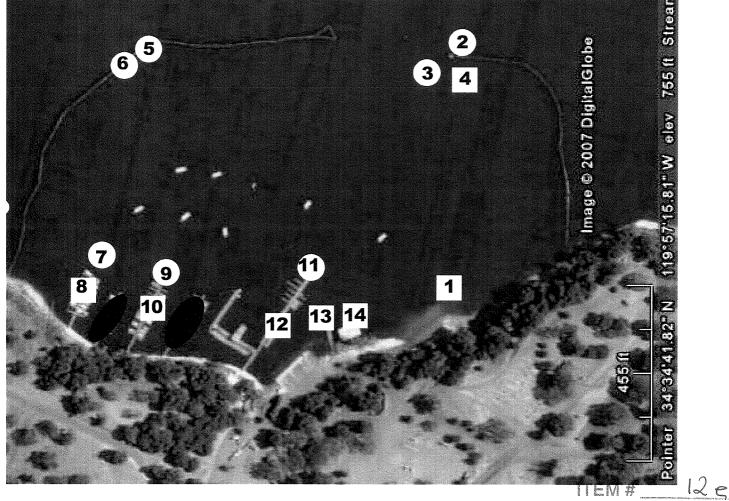

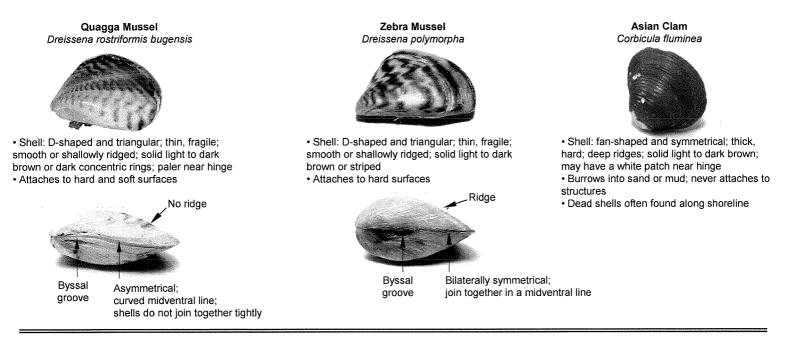
