SUBJECT: Quiota Creek Crossing 9 Fish Passage Improvement Project

RECOMMENDATION:

The Board approve Change Order No. 2 from Peter Lapidus Construction, Inc. (PLC) for the Quiota Creek Crossing 9 Fish Passage Improvement Project in an amount not to exceed \$43,826.

SUMMARY:

The Quiota Creek Crossing 5 and Crossing 9 Fish Passage Improvement Project(s) were publicly distributed for open competitive bidding on 5/1/18 and are considered as one project with two subprojects (Crossing 5 and Crossing 9). Bids were evaluated and a construction contract was awarded to the lowest responsible responsive contractor, PLC. Although the projects were bid together, separate construction contracts and budgets were developed for each project. These projects are located on S. Refugio Road which is a County of Santa Barbara (County) owned road and required a County Encroachment Permit wherein the County reviews and approves the project designs. All local and environmental permits for the project have been obtained and followed.

Specifically for the Quiota Creek Crossing 9 Project, PLC was awarded the construction contract on 6/11/18 for \$709,600 and the Notice to Proceed was issued on 9/4/18. Construction started on 9/5/18 and the estimated completion date for the project is 12/5/18.

During the final approval of the designs for the County Encroachment Permit for the project, the County required a change in the designs to comply with a CalTrans standard for road shoulder width under guardrails of 4 feet. This change was introduced well after receiving grant funding and awarding a construction contract. The original designs (and all 6 previously and successfully completed bridge projects of similar design along S. Refugio Road) had 2 foot wide shoulders under the guardrails. The additional 2 feet of shoulder width required more road embankment fill, the installation of additional rock slope projection (RSP) to hold the added fill, and construction of various tree wells within the area of the road embankments. On 11/5/18, the County made a further request to raise the northern approach road to the bridge by 2 feet to address a drainage issue on that side of the bridge and a slight road realignment to move the road away from a large oak tree for improved road clearance. The higher road requires more fill, installing a tree well, realigning a ranch access gate, extending the road tie-in point 36 feet towards the north that necessitates more road base and asphalt, and installing additional fencing that was not part of the original plans and contract. Finally, 2 drainage swales and 1 road scupper on the south side of the approach road to the bridge need to be added to accommodate road side drainage from the County road which goes up into the coastal mountains. These upslope road drainage issues were not addressed in the original plans. Change Order 1 (CO-1, Exhibit 1) encompasses a portion of the County requested items (mostly berm width increase under the guardrails) for a total amount of \$61,241.03 and all of this work has been authorized and completed. This contract increase falls within the COMB Procurement Policy limit for Board approval regarding change orders. Change Order 2 (CO-2, Exhibit 2) includes the rest of

the listed items for a total amount of \$43,825.92 and exceeds the authority limit per the COMB Procurement Policy and requires Board approval.

FINANCIAL IMPACT:

A summary of the project revenues and estimated project construction costs (Table 1) is presented below.

Change order Request #1

Description of change:

This change was required due to changes in the plan required by Santa Barbara County to accommodate a differing guard rail and road embankment shoulder detail & deepened RSP adjacent to bridge footings

There is no surplus fill available to create the widened shoulder detail for this project. Soil will have to be imported from outside the project limits. The cost for this is listed in the attached spread sheet. The material is anticipated to be procured on the adjacent property however the impact of this work will require some additional fencing and the relocation of the gate to the property and the construction of a new road onto the property. The work does not contemplate the drainage issues discussed on the site that could be mitigated with some additional grading outside the project boundary.


The rock work listed as RSP for shoulder widening and tree well construction is listed at the unit price for the RSP construction. In actuality this work is much more labor intensive than the placement of RSP. The work requires multiple machines, laborers, compactors and fabric.

In addition this change in the plans has caused a great loss in efficiency and completion of the projects will be delayed.


